Subject: Freedom of Information Act Request 2016-00928

This letter is in response to your Freedom of Information Act (FOIA) request submitted to npsfoia@nps.gov dated August 10, 2016, and received to my attention on August 11, 2016, in which you requested a copy of all records concerning the 2005 subsidence and settling of the Jefferson Memorial Plaza, and drops in groundwater levels under the Jefferson Memorial Plaza. Your request has been assigned FOIA Number NPS 2016-00928. Any correspondence with this office regarding this request should refer to this number.

We received an identical FOIA request dated July 29, 2016, for a copy of all records concerning the 2005 subsidence and settling of the Jefferson Memorial Plaza, and drops in groundwater levels under the Jefferson Memorial Plaza. Therefore, we are providing you with the same response and records released.

We are writing to partially respond to your request. We have enclosed 1121 pages of records that are responsive to your request which are being released to you in part. Portions of these materials are being withheld under the following FOIA Exemptions.

We are withholding 2 pages in full under FOIA Exemption 3. <u>5 U.S.C. § 552(b)(3)</u>. Exemption 3 allows the withholding of information protected by a nondisclosure provision in a federal statute other than FOIA. The National Park Omnibus Management Act (54 U.S.C. § 100707) protects information concerning the nature and specific location of endangered, threatened, rare, or commercially valuable National Park system resources. The information being withheld consists of information relating to sensitive utilities which, if released, could be used to circumvent or damage those systems and accordingly harm the resource and/or park visitors or employees.

We reasonably foresee that disclosure would be prohibited by law or otherwise protected from disclosure under Exemption 3.

All communications concerning your appeal should be clearly marked with the words: "FREEDOM OF INFORMATION APPEAL." You must include an explanation of why you believe the NPS's response is in error. You must also include with your appeal copies of all correspondence between you and NPS concerning your FOIA request, including your original FOIA request and NPS's response. Failure to include with your appeal all correspondence between you and NPS will result in the Department's rejection of your appeal, unless the FOIA/Privacy Act Appeals Officer's sole discretion) that good cause exists to accept the defective appeal.
