Dear Mr. Greenewald:

This letter responds to your recent Freedom of Information Act (FOIA) request which was assigned to the Consumer & Governmental Affairs Bureau (CGB) and the Enforcement Bureau (EB) on October 20, 2009. You seek: "all records identifiable as complaints regarding the television show 'The Glenn Beck Show' between January 2009 and the present."

You indicated in your FOIA request that you would be willing to pay a maximum fee of \$10.00 to process your request. Sharon Jenkins of my staff contacted you by email on October 21, 2009, to advise you that the estimated cost to process your request could reach \$20.00. You responded by email modifying your request to seek only the first 100 pages of complaints found in our databases and to indicate the remaining number of complaints.

Ms. Jenkins searched the databases containing informal complaints and identified approximately 300 complaints responsive to your request. Your modified request seeks the first 100 pages of documents responsive to your request or 50 complaints, which are enclosed. Ms. Jenkins redacted all personal identifying information relating to the individuals who submitted or are named in the complaints based on Exemption 6 of FOIA, which permits agencies not to disclose files that would clearly invade personal privacy.<sup>1</sup> EB has informed CGB that a search of its records revealed no documents responsive to your request.

The FCC receives many complaints and comments that do not involve violations of the Communications Act or any FCC rule or order. Thus, a complaint or comment does not necessarily indicate any wrongdoing by any individuals or entities named in the complaint or comment.

As Ms. Jenkins discussed with you, FOIA and FCC rules require the FCC to charge requesters for time spent searching for and reviewing responsive documents, and for copying them.<sup>2</sup> Based on your classification as a member of the news media, you are responsible for paying only copying costs beyond the first 100 pages. Because your modified request was limited to the first 100 pages of responsive complaints found in our databases, there are no charges.

If you think this response denies your FOIA request, you may file an application for review of this decision with the FCC's Office of the General Counsel within 30 days.<sup>3</sup> Both the application and envelope containing it must be marked "Review of Freedom of Information Action" and the application should refer to FOIA Control No. 2010-034.

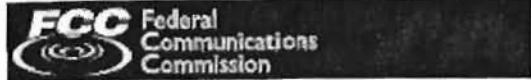
