Dear Mr. Greenwald:

This letter responds to your recent Freedom of Information Act (FOIA) request which was assigned to the Consumer & Governmental Affairs Bureau (CGB) and the Enforcement Bureau (EB) on October 20, 2009. You seek: "all records identifiable as complaints regarding the television show 'The O'Reilly Factor' between January 2009 and the present."

Sharon Jenkins of CGB searched the databases containing informal complaints and identified 23 complaints responsive to your request, copies of which are enclosed. Ms. Jenkins redacted all personal identifying information relating to the individuals who submitted or are named in the complaints based on Exemption 6 of FOIA, which permits agencies not to disclose files that would clearly invade personal privacy.<sup>1</sup> EB has informed CGB that a search of its records revealed no documents responsive to your request.

The FCC receives many complaints and comments that do not involve violations of the Communications Act or any FCC rule or order. Thus, a complaint or comment does not necessarily indicate any wrongdoing by any individuals or entities named in the complaint or comment.

FOIA and FCC rules require the FCC to charge requesters for time spent searching for and reviewing responsive documents, and for copying them.<sup>2</sup> Based on your classification as a member of the news media, you are responsible for paying only copying costs beyond the first 100 pages. Because responding to your request required copying less than 100 pages, there are no charges.

If you think this response denies your FOIA request, you may file an application for review of this decision with the FCC's Office of the General Counsel within 30 days.<sup>3</sup> Both the application and envelope containing it must be marked "Review of Freedom of Information Action" and the application should refer to FOIA Control No. 2010-035.

I'm writing to complain about "The O'Reilly Factor"'s use of what can only be described as stalking in order to paint people O'Reilly disagrees with in a negative light. I am aware that the FCC holds limited jurisdiction over cable programming, but the following situation was so genuinely appalling I felt I had to notify any potentially proper authorities. 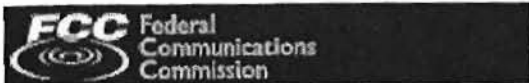

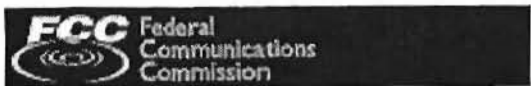
