Dear Mr. Greenewald:

This is in final response to the request for information that you sent to the Department of Energy (DOE) under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. You requested the following:

A copy of all complaints submitted about your agency's cafeteria (at Headquarters) including all correspondence relating to these complaints (which would include internal agency communications, emails, memos, etc.) for the calendar years of 2014 and 2015.

Your request was assigned to DOE's Office of Management (MA-40) to conduct a search of its files for responsive documents. MA-40 began its search on July 25, 2016, which is the cutoff date for responsive documents. MA-40 has completed its search and located ten (10) documents responsive to your request. The documents are being provided to you as described in the accompanying index.

Upon review, DOE has determined that certain information in the documents should be withheld pursuant to Exemptions 5 and 6 of the FOIA, 5 U.S.C. § 552(b)(5) and (b)(6).

Exemption 5 protects from mandatory disclosure "inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than a party in litigation with the agency." 5 U.S.C. § 552(b)(5). Exemption 5 incorporates the deliberative process privilege which protects recommendations, advice, and opinions that are part of the process by which agency decisions and policies are formulated.

The information withheld under Exemption 5 includes deliberative discussions between DOE employees and contractors. This information is both pre-decisional, because it was developed before the agency adopted a final policy, and deliberative in that it reflects deliberations, comments, and assessments made by individuals who were consulted as part of the decision-making process. Furthermore, disclosing the information would harm the deliberative process by compromising the ability and willingness of those who contributed to the process to make honest and open recommendations to each other. Thus, portions of the document are being withheld

under Exemption 5 of the FOIA as pre-decisional material that is part of the agency's deliberative process.

With respect to the discretionary disclosure of deliberative information, the quality of agency decisions would be adversely affected if frank, written discussion of policy matters were inhibited by the knowledge that the content of such discussion might be made public. For this reason, DOE has determined that discretionary disclosure of the deliberative material is not in the public interest because foreseeable harm could result from such disclosure.

Exemption 6 generally is referred to as the "personal privacy" exemption; it provides that the disclosure requirements of FOIA do not apply to "personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." 5 U.S.C. § 552(b)(6). In applying Exemption 6, DOE considered: 1) whether a significant privacy interest would be invaded; 2) whether the release of the information would further the public interest by shedding light on the operations or activities of the Government; and 3) whether in balancing the privacy interests against the public interest, disclosure would constitute a clearly unwarranted invasion of privacy.

The information withheld under Exemption 6 consists of individuals' names and contact information such as phone numbers and email addresses as well as mobile telephone numbers, and personal information about an individual. This information qualifies as "similar files" because it is information in which an individual has a privacy interest. Moreover, releasing the information could subject the individual to unwarranted or unsolicited communications. Since no public interest would be served by disclosing this information, and since there is a viable privacy interest that would be threatened by such disclosure, Exemption 6 authorizes withholding the information. Therefore, we have determined that the public interest in the information's release does not outweigh the overriding privacy interests in keeping it confidential.

This satisfies the standard set forth in the Attorney General's March 19, 2009, memorandum that when a FOIA request is denied, agencies will be defended and justified in not releasing the material on a discretionary basis "if (1) the agency reasonably foresees that disclosure will harm an interest protected by one of the statutory exemptions, or (2) disclosure is prohibited by law." The Attorney General's memorandum also provides that whenever full disclosure of a record is not possible, agencies "must consider whether they can make a partial disclosure." Thus, we have determined that, in certain instances, a partial disclosure is proper. This also satisfies DOE's regulations at 10 C.F.R. § 1004.1 to make records available which it is authorized to withhold under 5 U.S.C. § 552 when it determines that such disclosure is in the public interest. Accordingly, we will not disclose this information.

Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the determination to withhold the information described above. The FOIA requires that "any reasonably segregable portion of a record shall be provided to any person requesting such record after deletion of the portions which are exempt." 5 U.S.C. § 552(b). As a result, a redacted version of the documents is being released to you in accordance with 10 C.F.R. § 1004.7(b)(3).

This decision, as well as the adequacy of the search, may be appealed within 30 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to

Director, Office of Hearings and Appeals, HG-1, L'Enfant Plaza, U.S. Department of Energy, 1000 Independence Avenue, S.W., Washington, D.C. 20585-1615. The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.

The FOIA provides for the assessment of fees for the processing of requests. See 5 U.S.C. § 552(a)(4)(A)(i); see also 10 C.F.R. § 1004.9(a). In our June 30, 2016, letter, you were advised that your request was placed in the "news media" category. In this category, requesters are charged fees for duplication only and are provided 100 pages at no cost. Since DOE's processing costs for this response did not exceed \$15.00, the minimum amount at which DOE assesses fees, no fees will be charged for processing this request.

I'm writing to Inform you of my negative experience at I.L Creations, Forrestal Bldg, today, February 10. I recognize that you, as the reader of this email, are not responsible for my negative experience, however, I am still disturbed about the situation. Each time I patronize this food establishment the managerial staff are very rude. I am extremely concerned with the level of interaction that I had with them today.

I went to I.L Creations for lunch, as I was standing waiting for my colleagues, I observed the cashier who happened to to be a supervisor, snatched the condiment out of my colleague's hand and threw it in the trash. Her attitude and disposition was very rude and unprofessional. Upon my colleague leaving the line, I stated that she should ask to speak to another manager. Upon her speaking with another supervisor to inquire if/when did they begin charging for condiments and she other manager replied that I.L. Creations only charges for dressings, condiments were free. My coworker relayed the message to the cashier who then takes the condiment that my coworker previously had out of the trash and hands it to her! I was appalled that she would even think that it was appropriate to hand items that were in the trash back to a patron. The manager then approaches me and my colleague to further explain the condiment charges. Upon asking to speak with another manager, she walks away and begins to ring other guest out. After finding the other supervisor and explaining to her the level of disrespect and lack of customer service a gentlemen who identified himself as the owner stepped up and began to interject his thoughts. After letting him know my level of concern he became very nasty and dismissive. He also stated, after I asked for information to report a compilant, to "get out of his space." I was and currently am still very offended.

I am very disappointed with my experience and the level of customer service that I received today, although it has become the norm, it doesn't make it acceptable. Again, I am very dissatisfied and I think an apology from the management staff at I.L Creation is warranted.

I bought a small salad this afternoon in the cafeteria. Paid by credit card. Ate the salad and upon getting ready to leave noticed my receipt totaling 10.18 for the small salad. I walked over to the checkout person and said this looked incorrect. She said, no it was correct—that the plate measurement is handled by the machine. I said I doubted that it

was correct—she looked again, and realized she had entered the wrong plate type (I use the heavy reusable plate). She apologized and offered me a soda to make up for the mistake. I said I really felt that was inadequate and asked to speak to management. After quite a long wait Connie Kim arrived, spoke with her employee, determined it was their error and said she'd take 6.00 off the bill—I said I still was not satisfied and given the tremendous waste of time, would expect them to refund the whole cost, given it was their mistake in the first place. She was also not particularly apologetic—I felt I was being an inconvenience to her—but did hand me 6 bucks. I told her I would contact you.

She likely has not put in place any checks and balances to ensure customers are protected from a recurrence—I wonder how many DOE employees get over charged every day?

As a side note, the checkout line that I was on did not have any silver ware forks or knives—only plastic on offer—this is not good any day—and especially Earth Dayl They really should do better in terms of promoting the more sustainable options.





1J-018 Corrective action short term:

- The Building Manager and myself have spoken with IL Creations Management and ask that they ensure all sources of water are turned off every day before leaving duty.
- USF has been monitoring the space above 1J-018 for leaks which at the present none are visible.
- Didlake performed a thorough cleaning of the affected areas, including vacuuming, wiping down of all surfaces, a mild disinfecting and deodorizing.

Long term:

- ILC will develop a SOP and checklist of such sources that will be turned off each night. To be accomplished by ILC Management and review by GSA/FMO by COB Friday (March 28th2014).
- GSA and ILC have notified Kitchen Tech, they are scheduled to replace the falled piece of equipment today, FMO/GSA to follow up to ensure same.
- USF has been replacing ceiling tiles this weekend and have again today replaced all ceiling tiles. They will continue to monitor.

We will continue to provide updates to (b) (6) and (b) (6) and assist them with any concerns which may arise from this unfortunate occurrence.
