Dear Mr. Greenewald:

This is the final response to your enclosed October 28, 2016 Freedom of Information Act (FOIA) request for "DOD Instruction 0-2000.22." Your request was received in this office on October 31, 2016 and assigned FOIA case number 17-F-0159. We ask that you use this number when referring to your request.

The, Office of the Undersecretary of Defense for Policy (USDP), a component of the Office of the Secretary of Defense (OSD), conducted a search of their records systems. Mr. Patrick Antonietti, Director, Domestic CT & Global AT, an Initial Denial Authority for the Under Secretary of Defense for Policy, has determined that the document is exempt from release in its entirety pursuant to 5 U.S.C. § 552 (b)(7)(E), which pertains to records or information compiled for the purposes of enforcement of the physical protection of DoD high-risk personnel, the release of which would disclose certain guidelines or procedures that could be expected to risk circumvention of the law and agency security program responsibilities. The IDA also exempted the records under 5 U.S.C. § 552 (b)(7)(F), as release could reasonably be expected to endanger the life or physical safety of any individual.
