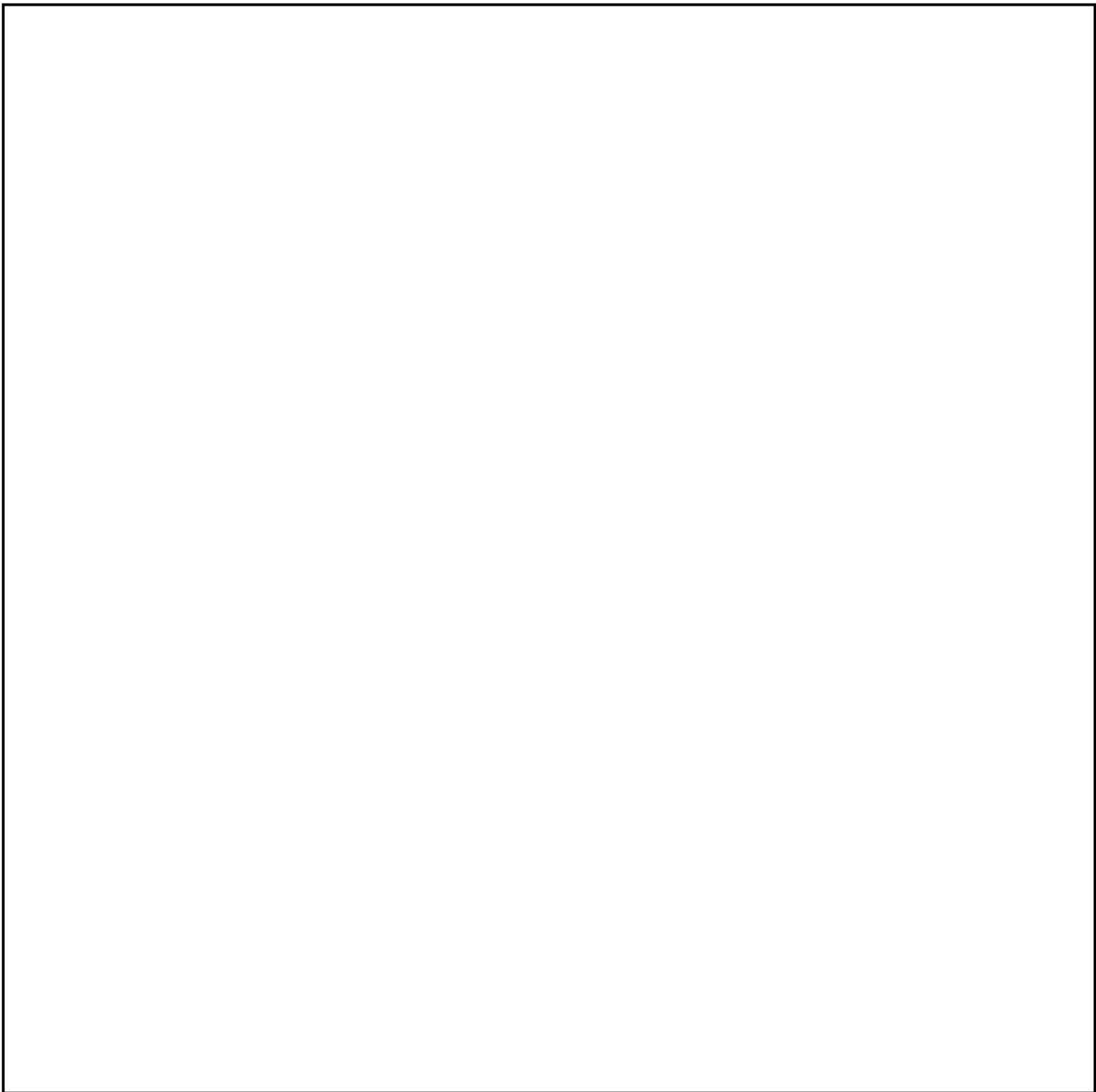

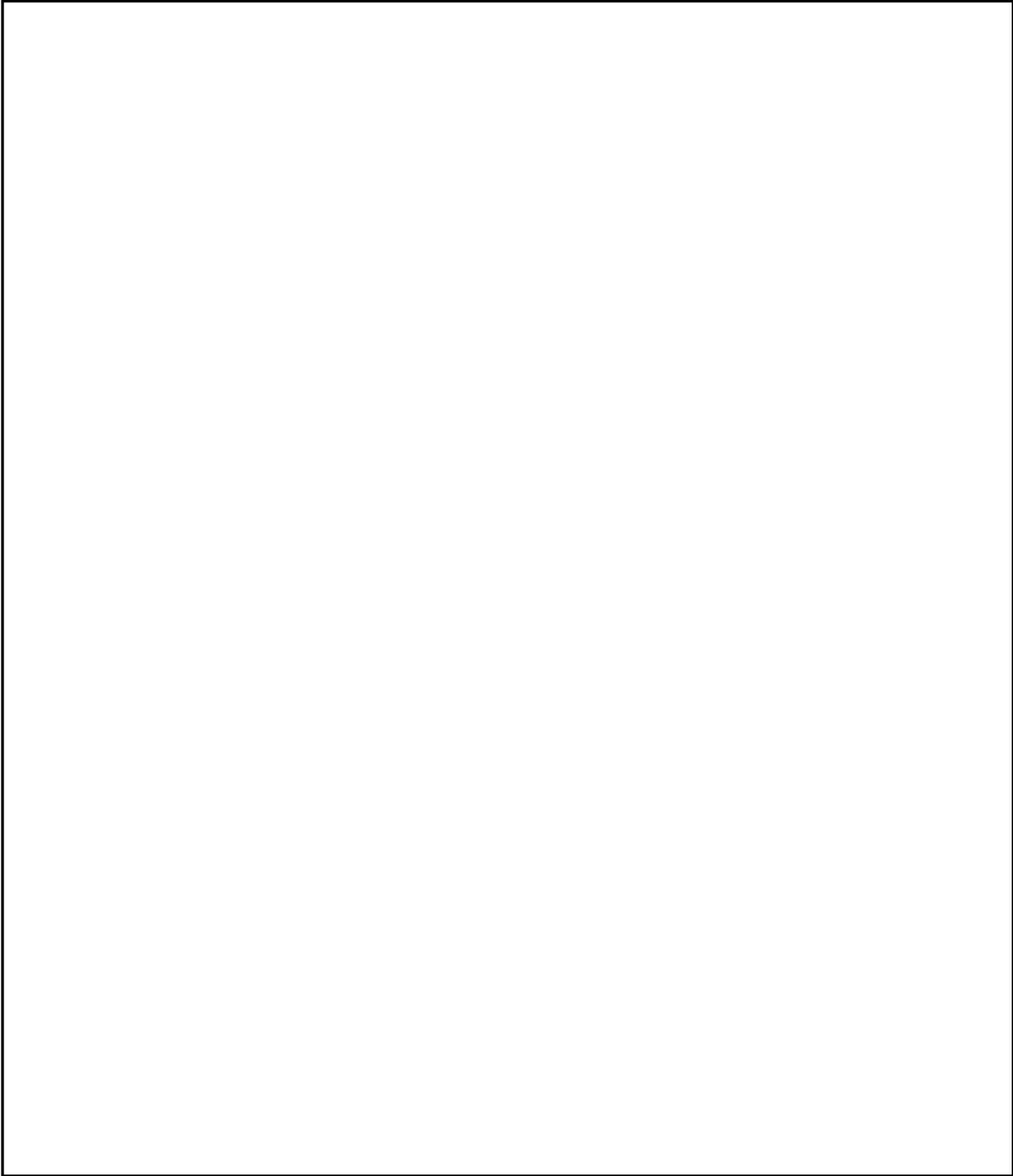

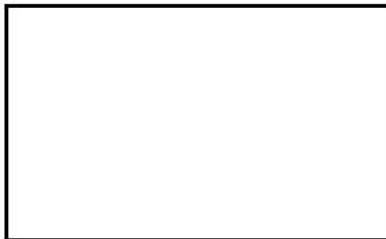

These provisions are consistent with and do not supersede, conflict with, or otherwise alter  
employee obligations, rights or liabilities created by existing statute or Executive order relating to:  
(1) classified information; (2) communications to Congress; (3) the reporting to an Inspector General of a  
violation of any law, rule, or regulation or of mismanagement, gross waste of funds, abuse of authority, or  
of a substantial and specific danger to the public health or safety; or (4) any other whistleblower  
protection. The definitions, requirements, obligations, rights, sanctions, and liabilities created by  
controlling Executive orders and statutory provisions are incorporated into this agreement and are  
controlling.
