I hope you receive this letter in good health and in good spirits. I requested that you act as liaison to bring about a peaceful solution, and now the FBI is openly involved.

But now aside from that tough guy bullshit, I must explain something to you. Im 33 years old and never had a real relationship in my life, I can't even slow dance. If it wasn't a woman much older than me it was a prostitute and this is the story of my life, because I didn't want to get emotionally involved.

Im not a bad looking dude and im not a homosexual, I tried to be faithful to the best of my ability all my life, because I knew someday GOD would see me through, I didn't know it was [REDACTED] I only knew there was someone in this world for me. They stole my life from me, and you know what people are thinking, "I thought he was a faggot" Do you know how hard it is for a faggot to get pussy these days? With the addition of AIDS, if a female has sex with a man she believes is a homo she is crazy.

Now my vacation went to waste, bugging out on [REDACTED] and all I asked for was a yes or no and I added to that a maybe. If im crazy and she isn't interested say no, what do she have to lose? If she isn't certain of what is going on, say I have to think about it. If she is interested say yes. But after what I went through for her I deserve a answer, because im a man with a serious problem, who devoted at the minimum two years, to receive one letter saying basically, [REDACTED] I know you exist.

[REDACTED] ask [REDACTED] about me, im a lonely dude. Say [REDACTED] who was [REDACTED] girl friend?

Don't take me wrong, because im not on my pity pot. I just want to expand on my position.

I believe I was 15 years old when the decision concerning what would come to past with [REDACTED] was made, I chose [REDACTED] over [REDACTED] because I knew [REDACTED] was gonna try to use me, by then it was clear to me. Also I was very young and extremely shy, and [REDACTED] was so fine and fully developed, like what was I gonna do with her?

[REDACTED] was at a better age for me to grow with, and she showed a interest in me that made me feel that she looked up to me, so I beat up some dude to impress her, I met him in Florida, we worked as dishwashers together, we made up. Like I said im interested in "Scarlet Dream" The Paul Castellano Estate, my father want's me to move in for awhile to clean the house, I may have to do it, because only I can, we should discuss this as well. I plan to come to California as soon as it is right.

To The L.A. CRIPS: As we all know the CRIPS are International, and most certainly nationwide. There's a lot of adjustments being made, such as the matching of CRIPS Charters to Local Masonic Lodges, Universal and Local Codes and so on.

But what I want to address is my visit to L.A. in the near future. Im not gonna come to L.A. intill [redacted] officially resigns, the power he has is unheard of, and the system he ran was unjust, he has to go, and that is the condition of my coming to California. Now you know anybody married to [REDACTED] as fine as she is, ain't gonna hide the fact, being aware of it, inless he is a punk, and punks get chumped for their women. [REDACTED] don't you know I will fuck [REDACTED] up really bad, over [REDACTED] so stop making me jealous alluding to [REDACTED] because it can never happen while im alive, not in reality.

Im gonna get intouch with agent [REDACTED] about this Monday, actually today, I'll give the FBI, [REDACTED] and the Jackson Family incill Monday to get their answers straight. I hope you receive this letter in good health and in good spirits; I want to tell you that you have been very helpful, rather you realize it or not. "Thank you very much"

I realize that you may not be taking me seriously, but "I AM" for real, and none of this is a joke.

[redacted] was born for me, she is a very important part of me, she can not marry anyone because she is already married to me, everything that she has is mines, and she is symbolic to a lot of things. "She is the wife of the Son of Man" for this reason I can't recognize her marriage to anyone but me.

Understand that Jesus Christ married the church, [redacted] is therefor symbolic of the church, among other things. So now understand the concept, in that I realize she was unfaithful, yet she must become once again faithful, in order to restore the purity of our marriage.

She must "Come back to me" in reality I didn't leave [redacted] she left me, it was in her heart to be unfaithful to me upon our reunion, and to keep her from being killed, because my wife must be faithful, I let her go, I allowed our separation again in 1989. "Come back to me" I wrote the letters, im the one who doesn't know where she is, im the one being hurt, not her. The bottomline is back in 1989, she believed I was a punk, and she was only out to use me, she didn't respect me as a man, nor did she have any respect for men. The important issue here is that if I can not put my house in order, how can I put GOD's house in order. And believe me, in 1989 my house was all fucked up, full of resentments, you name it.

See [redacted] was put through a lot, and was made confused. She didn't know I was [redacted] so she called herself using me, and being married to [redacted] Who she figured [redacted] to be, I don't know.

Now as I stated before, the timing of my taking her virginity was because she wasn't gonna be faithful, and she didn't know it was me. She was made to believe I was a faggot, because she was so worried about what I was doing, she couldn't be faithful, and that was the problem. I guess she figured [redacted] was just someone John Gotti used, and it was her duty to control me. "She didn't know who "I AM"

I knew we would be separated for a long time, and I didn't want any other man to touch her, and I knew she would be unfaithful, so I confused her sexuality and she called herself being faithful to a faggot, and resented it, because she carried a lot of shame and guilt. [redacted] would get into relationships with men because she was afraid of what people might think. Therefor she was made vulnerable to blackmail. For information, on 7/8/92, writer telephonically contacted HOLLY BECKNER, Deputy City Attorney, Los Angeles, California, (818) 902-2182, regarding the complaint she lodged with the FBI on 6/29/92 with respect to captioned matter.

According to BECKNER, subject [redacted] is currently in custody (LA County Jail) on a misdemeanor filing. The charges include two counts of terrorist threats, two counts of stalking and three counts of trespassing. However, BECKNER emphasized that these are all misdemeanors and the actual jail time he will spend if found guilty would be minimal. BECKNER is concerned, given subject's past history, that he truly is a dangerous person and poses a real danger to the JACKSONS and [redacted] is currently held on \$50,000 bail and his trial is scheduled to begin the week of 7/14/92.

BECKNER advised that the letters she faxed to the FBI are only a representative sample and the ones that clearly express threats to the JACKSONS and [redacted] There are in fact a large volume of letters that [redacted] has sent all over the country but with the basic theme of having to get back together with [redacted] and eliminating anyone who gets in his way. [redacted] stated that she has four sources for the letters: the U.S. Secret Service, [redacted] security agency, MICHAEL JACKSON's security agency and Paramount Studios.

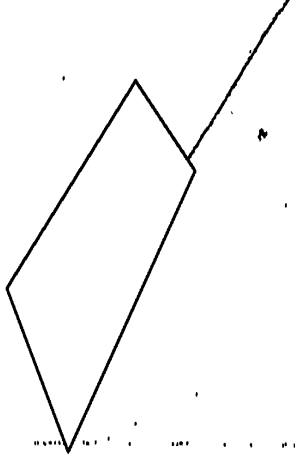

The advantage from my standpoint, which the most important, is once these shows are completed, I will be able to spend some real quality time with [redacted] and start a family.

- #4) I would like to add [redacted] to the team of professionals, and I would like for him along with EWF to create extended versions to all the songs to be released as singles, once again prior to the album release. An important aspect of the extended remix versions, is I want musicianship and musical engineering, not just turntable turning, and [redacted] can do the job.

- #5) On the singles releases, I want two songs released together on the 1st, 3rd, and 5th releases and one song on the 2nd, 4th, and 6th releases, and that should leave us three songs on reserve.

I want to completely dominate the charts early on in the album release, and promote the show by saying things like;

[redacted] is married and there will not be a concert tour with this album, this may be the last chance to see her perform live on stage for awhile, so on, and so on.

When we approach the last singles release, we can announce the release of the video of her live performances, or we can show it first on cable or network television.

- #6) Because we are gonna record at least seven video's prior to the album release, and we are gonna spend crazy money on the video's. I want to point out I want them to be very colorful with modern audio and video effects, with some acting in at least two of them.

Now what we can consider, im not sure about this one, we can consider releasing, The Elements of the World, music video set along with the album, for about \$15.00 being that Paramount Communications will be investing into the video's, they should consider the effect or impact this will have on the project. In the one hand people will jump on it, on the otherhand people will have seen and heard the whole package early on.

The result of a music video set release could result in our inability to decide on the singles release. But it could pay off big if we put together good extended singles for radio broadcast, do a good job promoting the concert, and do a good job promoting the concert video.

Now what would be great is if we can effectively enforce some type of copy right law to prevent T.V. broadcast from airing any video that has not been released, this will work. We will develop an enormous interest in the package early in it's release. We can have MTV, BET, VH1, and whoever else saying, if you really want to understand the message behind [redacted] new project you have to see the video set, it's really deep, but unfortunately because of copy right laws we can only play them as they are released as singles, which I can understand, considering they invested an estimated \$30M on the video's alone.

- #7) As for the star studded audience, the catch is that they will be coming to pay tribute to [redacted] the first lady of peace.

The audience will be an important part of the show, the fan's will see clips of them coming in and so on, I want the star studded audience to be set up with tables that are served (waited on) and I want Soul Train Dancers all over the place, it's a celebration to remember, that may never be matched. And it's important that we clearly promote the idea that you don't have to gamble to visit Atlantic City, because Atlantic City offers all sorts of great great entertainment for the whole family.

#8) Concerning the stage show, I want the best technical crew that money and influence can gather for a single event. It is very important that we put together a stage that will allow us to create different types of effects. Also keep in mind the star studded audience and the Soul Train dancers will be very much a part of the show, therefore some of the effects should extend to them. For example, smoke laid across the audience floor. Just keep in mind, this is to be a major event, and a really big show.

#9) In order for this to work, the movie theaters that will carry the show, will have to set up sound systems that will allow them to carry a concert sound. So we are talking about major investment dollars. [redacted] may have to sell the idea that these theaters have to look at it as a long term investment, for a new era of entertainment. Now we will need to establish contractors that will be certified by a entertainment committee, that will establish the Studio Standard, the the theaters must meet.

Also let's consider how [redacted] recordings are played back, I want a minimum of \$20M a year for three years upon the release of

[redacted] new album release, with a \$5M bonus upon the new album release in advertisement endorsements, from consumer electronic companies. This is my minimum standards and as for the commercials, we will do all the work before the album release.

#10) I suggest to [redacted] that this album cover be more colorful than [redacted] and watch who you thank and for what, im sorry but I do get jealous. But in general the [redacted] cover concept wasn't bad, to include the words to each song inside, is very effective. I want to insure quality and control over the actual tapes to insure consumer protection. I want the tapes to offer hours of defective free playing time, if you know what I mean. Also you might consider on the back of the package, rather than just advertise the names of the songs, advertise the package inside. For example [redacted] This is a Earth Wind And Fire Performance:

A [redacted] Words to Songs Inside: Fan Club Information Included: And so on. Remember the package sells the product, so use it to advertise. Don't just go on your name, humble yourself and try to reach out.

#11) We can consider releasing a limited edition special remix album, which will consist of the remixed singles released, which will be a group of remixed extended versions. Perhaps our standard might be the number one hits from the album The Elements of The World.

#12) I want all of [redacted] fan mail put into storage for at least five years, and the addresses of the senders put on a disk, with the date of the mail arrival and I want a system of retrieval. I want the system to automatically kick of an alarm when a name or address comes up on a consistant basis. If there is a fan out there really interested in [redacted] I want to know. What happened to me, I don't ever want to go unnoticed again. This will be a part of my security team's responsibilities.

#13) Concessions such as T-Shirts, Caps, Sweat Suits, Posters, and so on. A lot of concessions sales will be effected in one hand, but boosted on the other. Because there will be no concert tour, to prevent an over stock we may have to limit our stock among the theaters and be willing to except any unsold undamaged products back. The adjustment I want to make to more then balance this out is, to not use concessions to advertise the project, but to promote the idea behind the project, which is love.

I want our products sold as sports wear right beside [redacted] [redacted] and right beside Black Cultural type concessions, it's not all about glamour, it's about the message. Also I want to do business with the street venders. As I said, it's about the message, so I want our items to be seen, remember that the Wind blows wherever it pleases.

And I want to close this letter by saying that the actual details concerning this project should remain confidential for copy right purposes, and I respect that you all are professionals and will be able to work it out.

1. I am a Special Agent (SA) with the Federal Bureau of Investigation (FBI), United States Department of Justice. I have been an FBI agent for thirteen years. I am currently assigned to the Major Case Squad of the Los Angeles Field Office which investigates, among other things, threats received through the mail. This affidavit is made in support of a criminal complaint charging [REDACTED] with violation of Title 18, United States Code, Section 876: mailing threatening communications.

2. On July 8, 1992, Holly Beckner, Deputy City Attorney, Los Angeles City Attorney's Office, told me the following:

a. She was in possession of between thirty and forty letters written by [REDACTED] to [REDACTED] in which [REDACTED] made a number of allegations and threats, not only against [REDACTED] but also against [REDACTED]

[REDACTED] President George Bush, and others.

b. All of the letters had either been mailed through the United States Postal Service or had been sent by facsimile machine to various recipients in different parts of the country.

4. On July 14, 1992, I reviewed the letters provided to me by Holly Beckner. Most of these letters were addressed either to [redacted] or to [redacted] at 14755 Ventura Boulevard, # 1-710, Sherman Oaks, California 91403. The address on Ventura Boulevard is an address [redacted] uses to receive mail. Most of these letters list the sender as [redacted] which is a name [redacted] uses, although some of the letters list the sender as [redacted]. The letters bear postmarks showing that they were sent through the United States Postal Service.

5. The letters contain a number of different threats to various people. Although the overall tone of the letters is

threatening to [redacted] there are no explicit threats to her. The following are examples of the letters sent by [redacted]

a. The first letter from [redacted] to [redacted] is dated February 5, 1992. The letter begins "Dear [redacted] and in the letter [redacted] describes himself as [redacted] husband. I will do everything in my power to destroy them, and your persistence on this issue will only confirm to me, that this is what you want me to do." He signs this letter, [redacted] your husband)."

c. Another of the letters is dated May 18, 1992. This letter was sent by facsimile machine to the New York Daily News and signed [redacted] After complaining about his inability to attract [redacted] attention, he writes, "So I decided to go to the FBI today, if that doesn't work, I'll go to the CIA, military intelligent (sic) on up to the office of the President of the United States of America, and if the chain of command

doesn't work, I will resort to violence, to bring attention to my problem. I'll commit mass murder at a Michael Jackson concert if necessary, in an attempt to murder Michael" Also, he complains about a financial disagreement with Michael Jackson and writes, "Michael I will personally attempt to kill if he doesn't pay me my money."

d. In a letter dated May 19, 1992, originally sent to [redacted] a radio personality in New York, [redacted] states, "As I said, [redacted] could not marry another man, for she has always been my wife, and I consummated our marriage when I took her virginity when she was 13 years old."

e. [redacted] sent the United States Secret Service and others a letter dated May 21, 1992, addressed to "All Concerned Parties" and signed by [redacted]. The letter states in part, ". . . since nobody is taking me serious, and I can't handle my state of mind, then I am going to Washington D.C. to threaten to kill the President of the United States, George Bush. If they do not arrest me or solve my problem I'm gonna attempt to kill President George Bush. No answer from [redacted] is the only wrong answer and I will not accept it."

While there was no explicit threat to [REDACTED] the letters taken in their totality constitute a threat [REDACTED].

[REDACTED] explained that [REDACTED] the perceived threat potential he represents, his ability to get close to [REDACTED] and the frequency of his contacts (letters), all make [REDACTED] a high risk and trigger the highest alert as far as his security detail is concerned.

[REDACTED] advised that the letters currently in possession of the FBI do not constitute all of the letters sent by [REDACTED]. He has several more which were not given to the city attorney's office simply because no threat was contained in them. Nevertheless, he offered to provide the letters to the FBI as they will serve to show the gradual increase in tone and threat level.

[REDACTED] advised that he will be on vacation starting this date. However, he provided his home telephone as [REDACTED] and his Skypager number as [REDACTED].

On July 28, 1992, [redacted] was interviewed by Special Agent (SA) [redacted] of the Federal Bureau of Investigation (FBI) Los Angeles Field Office. After identifying himself through a show of credentials, SA [redacted] explained to [redacted] that he was being interviewed regarding his knowledge of the events leading up to the arrest of [redacted] by Los Angeles Police Department (LAPD) officers on June 22, 1992. The interview took place on the grounds of the JACKSON family estate, 4641 Hayvenhurst Avenue, Encino, California. The above arrest took place here. [redacted] works as a security guard at the residence and has been so employed for the past five years by MICHAEL JACKSON Productions.

Present during this interview was [redacted] attorney, representing [redacted]

Regarding the events of June 22, 1992, [redacted] advised that he was on duty at the front gate [redacted]. Sometime around 9:00am, as [redacted] was sweeping the driveway with the gate opened, [redacted] observed through the TV monitor the person later identified as [redacted] approaching [redacted] and the gate. [redacted] proceeded down the driveway. AS he got closer, he immediately recognized the individual as [redacted] based on the photograph of [redacted] kept in the Potential Dangerous Person (PDP) manual provided by the JACKSON security detail. [redacted] described it as an "alert book" which identifies all those individuals believed to pose a risk or threat to the JACKSON family as a result of their celebrity status.

[redacted] stated that he told [redacted] "Sir, this is private property - wait on the other side of the street". [redacted] started asking for [redacted] and [redacted]. [redacted] advised that neither was at home. Then [redacted] asked to speak to [redacted]. Again, [redacted] told him she was not there either. All the while, the gate, which is on a timer, was closing until [redacted] was on one side of the gate, still

At this time, responding to [REDACTED] questions of who he was and what he wanted [REDACTED] stated that he was JOHN GOTTI's son and also [REDACTED] husband. While he could see [REDACTED] via the TV monitor sitting on the sidewalk in front of the gate, [REDACTED] once again asked him through the intercom to identify himself. When [REDACTED] confirmed his identity, [REDACTED] called the police. In fact, [REDACTED] stated that four calls were made before the police responded with four patrol cars. In the meantime, [REDACTED] observed [REDACTED] via the TV monitor. Knowing that [REDACTED] was potentially dangerous, [REDACTED] did not want to force [REDACTED] to move.

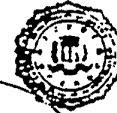

Man ruled incompetent for trial in death threats

A federal judge ruled Tuesday that a New York man is incompetent to stand trial on charges he threatened to kill President Bush and entertainer Michael Jackson to get the attention of singer Janet Jackson.

U.S. District Judge A. Andrew Hauk said Frank Paul Jones may be suffering from a mental illness, and he ordered that Jones be evaluated by psychiatrists and placed in the custody of a mental hospital, said Assistant U.S. Attorney Gregory W. Jessner.

Hauk issued his ruling in Los Angeles after a competency hearing requested by federal Deputy Public Defender Myra Sun.

Jones, 33, was arrested June 22 on the grounds of the Jacksons' parents' home in Encino.

Misdemeanor stalking and trespassing charges were dismissed in Van Nuys Municipal Court so federal prosecutors could proceed with a charge of mailing threatening communications, which carries higher penalties.

One month before his Encino arrest, Jones was arrested by White

House police for attempting to enter White House grounds in what appeared to be an effort to get Janet Jackson's attention, according to an affidavit filed in support of the federal charge.

The incident came a day after Jones wrote a letter threatening to kill Bush, according to the affidavit.

"Since no one is taking me serious, and I can't handle my state of mind, then I am going to Washington, D.C., to threaten to kill the President of the United States, George Bush," the letter said.

"If they do not arrest me or solve my problem, I'm gonna attempt to kill President Bush," he wrote. "No answer from Janet is is the only wrong answer and I will not accept it."

The affidavit said Jones also threatened to kill entertainer Michael Jackson to get the attention of his sister, Janet Jackson.

In his written ruling, Hauk said Jones is "presently suffering from a mental disease or defect rendering him mentally incompetent to the extent that he is unable to understand the nature and consequences of the proceedings against him or to assist properly in his defense."

A New York man who was obsessed with pop singer Janet Jackson and believed he was married to her was sentenced Monday to two years in prison on one count of mailing a threatening communication.

Frank Paul Jones, 34, initially was charged with four counts of sending threatening letters, including two to Jackson, one to her boyfriend, Rene Elizondo, and another to director John Singleton, who worked with her on the soon-to-be-released film "Poetic Justice."

Jones pleaded guilty to one count involving a threat to Elizondo, said Assistant U.S. Atty. Gregory Jessner. Jones was charged last summer, but found incompetent to stand trial. He was treated in a federal correctional institution in North Carolina until doctors determined that he had recovered enough to return to court, Jessner said.
