A LETTER TO ALL STUDENTS AND FACULTY MEMBERS HOLDING DRAFT CARDS:

Tomorrow, the anniversary of Abraham Lincoln's birthday, several thousand American men are going to attempt to emancipate themselves from peacetime conscription by publicly ridding themselves of their draft credentials, either by mailing them to the President or burning them in public bonfires. This sounds like a foolish, crackpot scheme but it's not. It is much worse than that - it is a form of civil disobedience. That's something rather old-fashioned but in times like these, when America's government is diverting the major portion of its expenditures to armaments and our military leaders are trying to fasten permanent peacetime conscription on the nation, then, as Thoreau said, "It is not too soon for an honest man to rebel.

These men are certainly honest and sincere, and they are rebelling, not only against what they consider a violation of personal liberty, but against the slow and deadly drift towards World War III which an international armament race and universal conscription make almost inevitable.



Pennsylvania, in March 1947, made available to the Pittsburgh Office of the Federal Bureau of Investigation, a typewritten notice on plain white, notebook paper, size 8-1/2" x 11", unruled, which he found posted on a bulletin board at the college.
This notice is signed in ink by EDWARD ABBET, and reads as follows:

A LETTER TO ALL STUDENTS AND FACULTY MEMBERS HOLDING DRAFT CARDS:

Tomorrow, the anniversary of Abraham Lincoln's birthday, several thousand American men are going to attempt to emancipate themselves from peacetime conscription by publicly ridding themselves of their draft credentials, either by mailing them to the President or burning them in public bonfires. This sounds like a foolish, crackpot scheme but it's not. It is much worse than that—it is a form of civil disobedience. That's something rather old-fashioned but in times like these, when America's government is diverting the major portion of its expenditures to armaments and our military leaders are trying to fastem permanent peacetime conscription on the nation, then, as Thorseu said, and it is not too soon for an honest man to rebel.

These men are certainly hobest and sincere, and they are rebelling, not only against what they consider a violation of personal liberty, but against the slow and deadly drift towards World War III which an international armament race and universal conscription make almost inevitable.



The March 11, 1951, issue of the "New Mexico Daily Lobo", a publication at the University of New Mexico, reflects a letter to the editor which is as follows:

WIn this day of the cold war, which every day shows signs of becoming warmer, the individual who finds himself opposed to war is apt to feel very much out of step with his fellow citizens. As an isolated individual he feels desperately inadequate either to check the tide or to make significant contributions which might serve to remove the occasion of wars. He feels, nevertheles the essential wrongness of war and is searching for an alternative.

"On the UNM campus such a group—it includes both students and faculty—has formed to discuss the implications and possibilities of resistance to war. This group has no political or religious affiliations. Although not desiring to create an organization, this group feels the need of informal association. Persons interested in associating with us may get in touch with one of the undersigned."



"Other than the contacts reported above, I have no personal, first-hand knowledge to report. As you can see, my own experiences have been ones which would incline me favorably toward Mr. ABREY. There are circumstances, however, which raise doubts in my mind as to Mr. ABREY's fitness for a civil service appointment. I shall try to set these farth objectively.

he demonstrated, as editor of our campus literary magazine, The Thunderbird, a quality of rashness and immaturity which was irritating, to say the least, coming as it did from a man of his intelligence and capabilities. You are in possession of the details, I know, so I shall not repeat them here. I am quite aware that my view of Mr. ABBEY's editorial irresponsibility is what might be termed an "administration" one and that others on the faculty and in the student body may not share it. My own protest concerned the wisdom of his presentation, not his right to the opinion expressed. Students on his staff, I have been told, had displayed sounder and more mature judgment in trying to dissuade him from printing the cover statement. His persistence in pursuing his own somewhat pointless course seemed to me to suggest a





stubborn ego, a taste for shocking the reader, a lack of maturity. I confess to annoyance with the whole affair which leaves my own objectivity in question; certainly I was disappointed in Mr. ABREY's performance as editor.

To me it is of importance principally as it is indicative of instability and poor judgment: Mr. ABBEY may now have outgrown this phase completely.

exhibited a copy of the March 1951 issue of "The Thunderbird" which had on the bottom of it the following quotation: "Man Will Never Be Free Until the Last King Is Strangled With the Entrails of the Last Priest." In small print under this quote was the name LOUISA MAE ALCOTT to which he attributed this quotation. In this respect, stated that this was the incident to which she had reference in her statement.

advised that she had no information concerning subject's connection with any peace group on the campus at the University of New Mexico during 1951.

advised that he was acquainted with subject and became acquainted with him as a student at the University of New Mexico during the spring of 1951. The occasion which caused his interest in subject was the printing of the campus literary publication, "The Thunderbird", March 1951 issue. Idvised that he received information that this publication had been printed at the University press and was about to be distributed with an alleged quotation on the front of it that "Man Will Never Be Free Until the Last King Is Strangled with the Entrails of the Last Priest." Stated that this quotation was attributed to LOUISA MAE ALCOTT.

he ascertained that subject was a brilliant individual who had definite possibilities in creative writing and one who was a creditable student at the University of New Mexico. As to why subject did this, he stated that during this particular period in the school year, there was somewhat of a religious crusade at the campus both by the Protestant and the Catholic religions.

Precalled these two crusades were right at the same time. He stated he always thought that this incident was somewhat connected with these crusades and that subject being the individualist that he was, was going his bit to emphasize religion in one manner or another at the time. He also felt that subject was egotistical and that he thought there was nothing particularly wrong with getting his name before the students in this manner.

peace movement started on the campus of the University of New Mexico by a group of individuals who admit they are pacifists and are against war of any type. He stated this group was somewhat started in this venture by a representative of an organization known as the "Fellowship of Reconciliation" which representative came from California. He stated this group worked among students at the University of New Mexico although they did not hold formal meetings on the campus. He stated however, that he knew of no subversive elements that were connected with the group and always considered that they were pacifists who did not believe in war or fighting in any manner whatsoever.

reflected adversely on the loyalty of the subject to the United States. He stated that he exhibited immature judgment in the printing of the quotation on the front of "The Thunderbird". aid that he attributes it to one of those "college kids functions" that usually comes about. He stated that in his opinion, subject used extreme bad judgment.





advised that he was acquainted with subject who was a student at the University of New Mexico in 1950-51.

California, came to the campus of the University of New Mexico as a representative of an organization known as the "Fellowship of Reconciliation." He stated this organization was a pacifist organization and did not believe in war.

stated that subject was interested in the same principles and described him as a pacifist. He stated the organization had a few informal meetings toward the end of the school year and no active organization was formed. He stated that none of the individuals on the campus of the University of New Mexico who were generall associated with Communism, were associated with this organization. He stated that at least he knew of no such individuals.

mentioned the incident in connection with the publication of the March 1951 issue of "The Thunderbird" at the University of New Mexico. He described the incident as one of those things that a young creative writer on a university campus might do at any school. He stated that as far as he knew, subject had no ulterior motive behind the incident whatsoever. He informed that he had no information that would reflect adversely on his loyalty to the United States.

He stated that following his marriage at Albuquerque, New Mexico, it was evident that his individualism might cause a rupture in his marital relations Subject and his wife did not get along too well, he being one who desired to follow his creative writing and she being one who desired a home and association with others explained that subject's wife accompanied him to Scotland but returned four or live months later and secured a divorce in Albuquerque. He stated it was purely incompatability on both their parts.

Concerning subject's loyalty stated that he has no information reflecting adversely on his loyalty to the United States. He mentioned, however, that subject was connected with an incident at the University of New Mexico while subject was editor of "The Thunderbird". He described "The Thunderbird" as a literary publication of the students at the University of New Mexico. subject was a definite individualist who had great ability in the creative writing field. He pointed out that he received a Fulbright scholarship and went to Scotland during the year 1951-52. He also pointed out that subject had written a story which, if finished, would be worthy of publication.



in regard to the incident concerning the campus literary publication "The stated that he was not concerned over this incident might do in campus activities.

He stated that the novel subject wrote was the story of one man who tries to live several lives and consequently fails to achieve any genuine kind of life at all. He stated the theme as expressed by subject is deceptive and betrayal and fraud with variations. The end is an ironic and melodramatic death for the hero in the wilderness mase symbolic of the futile, confused, contradictory, barren waste he has made of his own life.

On 3/9/67, U. S. National Park Service, furnished the following confidential information concerning EDWARD PAUL

He resides in the State of California housing area near the elementary school at Death Valley. The house is a duplex and the other half is occupied by Mr. and Mrs. DON BRAY. DON BRAY teaches high school at Shoshone, California. They moved into the area in about September, 1966. ABBEY lives at the residence with his wife, JUDY. They have no children and their mailing address is P. O. Box 246.

He is employed as a school bus driver for the elementary school at Death Valley, and also serves as maintenance man for the school. He spends a great deal of time working as a free-lance writer on his own. Prior to arriving in Death Valley, ABBEY was employed as a fire lookout at Lassen National Park, California from about June, 1966 to September, 1966. stated that in August, 1966, ABBEY sent a letter requesting employment as a part-time ranger in Death Valley but he was never hired for the job. 





II BASIS FOR INVESTIGATION

State Teachers College, Indiana, Pennsylvania, in March, 1947, made available to the Pittsburgh Office of the Federal Bureau of Investigation, a typewritten notice on plain white, notebook paper, size 8-1/2" x 11", unruled, which he found posted on a bulletin board at the college, This notice is signed in ink by EDWARD ABREY, and reads as follows:

A LETTER TO ALL STUDENTS AND FACULTY MEMBERS

HOLDING DRAFT CAPDS:

Tomorrow, the anniversary of Abraham Lincoln's birthday, several thousand American men are going to attempt to emancipate themselves from peacetime conscription by publicly ridding themselves of their draft credentials, either by mailing them to the President or burning them in public bonfires. This sounds like a foolish, crackpot scheme but its not. It is much worse than that—it is a form of civil disobedience. That's something rather old-fashioned but in times like these, when America's government is diverting the major portion of its expenditures to armaments and our military leaders are trying to fasten permanent peacetime conscription on the nation, then, as Thoreau said, "It is not too soon for an honest man to rebel."

These men are certainly honest and sincere, and they are rebelling, not only against what they consider a violation of personal liberty, but against the slow and deadly drift towards World War III which an international armament race and universal conscription make almost inevitable.

Among the men taking part in this national demonstration tomorrow are:



*Other than the contacts reported above, I have no personal, first-hand knowledge to report. As you can see, my own experiences have been enes which would incline me favorably toward Mr. ABBEY. There are circumstances, however, which raise doubts in my mind as to Mr. ABBEY's fitness for a civil service appointment. I shall try to set these forth objectively.

he demonstrated, as editor of our campus literary magazine, The Thunderbird, a quality of rashness and immaturity which was irritating, to say the least, coming as it did from a man of his intelligence and capabilities. You are in possession of the details, I know, so I shall not repeat them here. I am quite aware that my view of Mr. ABREY's editorial irresponsibility is what might be termed an "administration" one and that others on the faculty and in the student body may not share it. My own protest concerned the wisdom of his presentation, not his right to the opinion expressed. Students on his staff, I have been told, had displayed sounder and more mature judgment in trying to dissuade him from printing the cover statement. His persistence in pursuing his own somewhat pointless course seemed to me to suggest a stubborn ego, a taste for shocking the reader, a lack of maturity. I confess to annoyance with the whole affair which leaves my own objectivity in question; certainly I was disappointed in Mr. ABREY's performance as editor.

To me it is of importance principally as it is indicative of instability and poor judgment; if ARREY may now have outgrown this phase completely.

knowledge of it raises an honest doubt in my mind as to Mr. ABBEY's temperamental fitness for the position which he is seeking.

I was forced to express unis doubt in direct terms. I hope that I have been as fair and objective as possible.

"I should like to state emphatically that I have no reason, on the basis of any knowledge in my possession, to doubt Mr. ABREY's loyalty to the United States.

advised that he was acquainted with appointee and became acquainted with him as a student at the University of New Mexico during the spring of 1951. The occasion which caused his interest in appointee was the printing of the campus literary publication, "The Thunderbird," March 1951 issue.

advised that he received information that this publication had been printed at the University press and was about to be distributed with an alleged quotation on the front of it that "Mar Will Never Be Free Until the Last King Is Strangled With the Entrails of the Last Priest."

stated that this quotation was attributed to LOUISA MAE ALCOTT.

he ascertained that appointed was a brilliant individual who had definite possibilities in creative writing and one who was a creditable student at the University of New Mexico. As to why appointed did this he stated that during this particular period in the school year there was somewhat of a religious crusade at the cannus both by the Protestant and the Catholic religions.

The recalled these two crusades were right at the same time. He stated he always thought that this incident was somewhat connected with these crusades and that appointed being the individualist that he was was doing his bit to emphasize religion in one manner or another at the time. He also felt that appointed was egotistical and that he thought there was nothing particularly wrong with getting his name before the students in this manner.

Stated that appointed did express his regret at the time.

advised that during the spring of 1951 there was a peace movement started on the campus of the University of New Mexico by a group of individuals who admit they are pacifists and are against war of





any type. He stated this group was somewhat started in this venture by a representative of an organization known as the "Fellowship of Reconciliation" which representative came from California. He stated this group worked among students at the University of New Mexico although they did not hold formal meetings on the campus. He stated he did not know whether or not appointee was connected with this group. He stated, however, that he knew of no subversive elements that were connected with the group and always considered that they were pacifiets who did not believe in war or fighting in any manner whatsoever.

that reflected adversely on the loyalty of appointee to the United States. He stated that he exhibited immature judgment in the printing of the quotation on the front of "The Thunderbird." said that he attributes it to one of those "college kids functions" that usually comes about. He stated that in his opinion appointee used extreme bad judgment.

advised that he was acquainted with appointee slightly and has been since 1951. He stated that his acquaintance with appointee was occasioned by the quotation appointee put on the front of the literary publication The Thunderbird in March 1951. He advised that the publication was printed at the University press. Prior to its being printed

stated, however, that this being a student publication it was printed. He stated that he understood that the publication was not to be distributed but after receiving word to this effect the staff went ahead and distributed some of it.

advised that he knows no more of this incident. He stated that the conclusion on the campus seemed to be that it was one of those college pranks. He stated that he had heard nothing that would indicate that there was any subversive element behind the incident. He stated that as far as he knew appointee was loyal to the government.

that his acquaintance with appointee was

informed that he had visited in appointee's home at the outskirts of Albuquerque, New Mexico at Tijeras, New Mexico.

stated that appointee is a difficult person to describe. He stated that he was an exceptionally brilliant individual who graduated with honors at the University of New Mexico. He stated he was an individualist in his thinking in all respects. He was not a gregarious type of individual yet he shows evidence of desiring to be with people and share somewhat their expressions.

A LETTER TO ALL STOLENTS AND FACULTY MELBERS HOLDING DRAFT CARDS:

Tomorrow, the anniversary of Abraham Lincoln's birthday, several thousand American men are going to attempt to emancipate themselves from peacetime conscription by publicly ridding themselves of their draft credentials, either by mailing them to the President or burning them in public bonfires. This sounds like a foolish, crackpot scheme but it's not. It is much worse than that—it is a form of civil disobedience. That's something rather old-fashioned but in times like these, when America's government is diverting the major portion of its expenditures to armaments and our military leaders are trying to fasten permanent peacetime conscription on the nation, then, as Thoreau said, "It is not too soon for an honest man to rebel."

These men are certainly honest and sincere, and they are rebelling, not only against what they consider a violation of personal liberty, but against the slow and deadly drift towards World War III which an international armament race and universal conscription make almost inevitable.

Among the men taking part in this national demonstration tomorrow are:

Prof. Paul Schlipp Dr. Scott Nearing Northwestern University (Economist, writer)

If you are aware of the dangers of peacetime conscription, tomorrow is the time to do something about it. Send your draft card with an explanatory letter to the President. He'll appreciate it greatly, I'm sure.

I. PERSONAL HISTORY

The following background information pertaining to the appointee was obtained from his personnel file which is maintained by Geological Survey in Washington, D.C.

EDWARD PAUL ABBEY was born January 29, 1927, at Indiana, Pennsylvania. He graduated from the Indiana High School at Indiana, Pennsylvania, and he attended the University of New Mexico from January, 1948, until June, 1951, at which time he received an A.B. Degree. From September, 1951, until June, 1952, he attended the University of Edinburgh in Scotland on a Fulbright Fellowship.

Concerning his previous employment it was indicated that from June 25, 1944, until July 19, 1944, he was employed as a cannery laborer for the California Packing Company at Oakdale, California. From June 22, 1945, until February 13, 1947, he served in the U.S. Army and reported that from April, 1946, until December, 1946, he was a clerk-typist with the 88th Division of the U.S. Army at Gorizia, Italy. From November 15, 1948, until May 16, 1949, he was employed as an assembler for the General Electric Company at Erie, Pennsylvania. During July, 1952, he was employed as a clerk-typist by the Geological Survey where he is so employed at the present time and he resides at 1426 - 21st Street, N.W., in Washington, D.C.

III RESULTS OF INVESTIGATION

The personnel files of the Geological Survey of the Department of Interior, Washington, D.C., reflected a personnel folder pertaining to the appointee which revealed an application

for Federal employment dated July 9, 1952, wherein the appointee recorded his address as 1426 - 21st Street, N.W., interashington, D.C. This form 57 also reflected that the appointee listed his marital status as single and that he had traveled to Scotland and Europe. In addition it was listed that ABBEY had served in the U.S. Army from June 22, 1945, until February 13, 1947, having Army Serial Number 339741357 It was noted that the appointee listed the following references for Government employment:

> H. G. ALEXANDER, University of New Mexico, Albuquerque, New Mexico

E. W. TEDLOCK, (same address as above)

KATHERINE SIMONS, (same address as above)

This personnel file concerning the appointee also revealed a Personal History Statement executed July 16, 1952, in which the appointee listed his marital status as divorced. It was also noted on an appointment affidavit which was executed July 16, 1952, that in case of an emergency the appointee's father PAUL ROLABBEY of Home, Pennsylvania, should be notified.

These records also revealed that on July 16, 1952, EDWARD PAUL ABREY received an indefinite appointment as a clerk-typist in the Water Resources Division of the Geological Survey, Department of the Interior, in Washington, D.C., where he is employed at the present time.

is in contact with his intrequently

during working hours. He also explained that occasionally the appointee drops by his office and they engage in conversation which usually pertains to the work in the Geological Survey. He related he knew very little concerning the appointee's background and outside activities but he commented that ABREY planned to return to school sometime during October. adso reported that recently the appointee took several days off from work to take an examination for the Foreign Service of the Department of State.

commented the appointee impressed him as being a quiet and reserved person who is a satisfactory employee. He added he knew of no organizations to which ABBEY belonged and that from his brief contact with him he had no reason to doubt the appointee's loyalty to the United States.

Geological Survey Desertment of the Interior, Washington, D.C., advised

working day. He reported the appointee impressed him as a person of fine attributes and he considered him to be a desirable employee. He commented he did not know with whom ABHEY associated and he knew of no organizations to which the appointee belonged. He recalled ABHEY attended the University of New Mexico and that he had studied abroad but he stated that the appointee had not discussed his activities in this connection. He also reported that it is ABHEY's intention to return to the University of New Mexico sometime during the middle of October. Subsequently related that ABBEY's last working day in Washington, D.C., would be October 2h, 1952, and that ABBEY planned to connect himself with the Albuquerque Office of the Geological Survey and perhaps further his education at the same time.

remarked the appointee has made no statements contrary to the best interests of the United States and that he considers him to be loyal to this country.

Geological Survey, Department of the Interior, Washington, D.C.

during that period of time she has ascertained ABRET was a major in philosophy at the University of New Mexico and he also studied abroad. She recalled that the appointee remarked that he returned to the United States without finances and a friend suggested that he should come to Washington, D.C., and obtain a position with the Government. She added that she did not know the identity of this individual who advised ABBEY.

stated that she did not know where ABBEY resides in Washington, D.C., and she had no information concerning his background activities or associates. She continued he is a

very quiet individual who is difficult to understand and know. She remarked she dould not determine whether he is serious or whether he is joking on occasions.

reported that she was unable to recall all of the statements that ABBEY has made but she reiterated that he was difficult to make out. She added that she had no information that would reflect against the appointee's loyalty to the United States.

Geological Survey. Department of the Interior, Washington, D.C., advised has learned that has learned that the appointee comes from a large family in Pennsylvania. He stated he understood that ABBEY considered his second home to be with his grandfather who resides in Tigeras Canyon in New Mexico. He also recalled that ABBEY had been employed in connection with an oil rig in New Mexico and that ABBEY had also attended the University of New Mexico and studied philosophy. He stated that the appointee had also spent approximately one year in Scotland furthering his education and in fact the appointee only returned from that country approximately six months ago.

He added ABBEY has not discussed his activities in connection with his trip abroad.

reported that ABBEY is divorced from his wife and he resides at Wesley Hall in Washington, D.C. He also reported that he had no information concerning ABBEY's social acquaintances or activities in Washington, D.C., but he did recall that ABBEY had a friend who is employed in military geology. He stated, however, that he could not identify this individual who is reported to be acquainted with the appointee. remarked that the appointee is a quiet person who has never engaged in any political discussions to his knowledge. He commented that ABBEY is a person who stands strongly for equality and explained that the appointee has spoken against discrimination when it had been evident on several occasions in the office. He continued, however, that ABBEY approaches any question from a philosophical viewpoint and reflects the viewpoints of both sides on any issue. He added there has been no conversation or action on the part of ABBEY that would reflect against his loyalty to the United States.

present time. The reported that she does not know the appointee personally and she was unable to advise as to whom the appointee knew in the building.

advised he has known the appointee since late August and has ascertained that the appointee originally came from Indiana, Pennsylvania. He continued that he has also learned that ABBEY attended the University of New Mexico and that he studied philosophy in Scotland. The reported that the appointee plans to leave Washington, D.C., in the near future and continue his education at the University of New Mexico.

stated that ABBEY is a quiet individual who spends most of his time writing philosophy. He commented ABBEY goes

out very infrequently and his only associate is a person he formerly knew at the University of New Mexico. He reported that ABBEY and this friend usually spend their evenings together talking and writing philosophy but he could not further identify this associate of the appointee.

since he had been an editor at the University of new mexico, which understood him to may published material which had been radical in content. advised that he did not pay too much attention to the incident at the time, and he could recall no further remarks concerning the incident.

related that the appointee belonged to no organizations to his knowledge and he stated that ABREY had made no remarks that would indicate disloyalty to the United States.

The records of another Government agency which conducts personnel investigations, were utilized during the course of this investigation.

The records of the House Committee on Un-American Activities reflected no information which could be identified with the appointee's name.

The records of the Passport Division of the Department of State reflect that EDWARD PAUL ABBET was issued passport number 499010 on August 22, 1951, for a proposed ten month travel to England, Scotland, France and Germany to attend the University of Edinburgh on a Fulbright Scholarship. He stated in his passport application dated August 8, 1951, at Albuquerque, New Mexico, that he intended to depart from the port of New York by ship about December 15, 1951. This passport was not valid for travel to Japan, Okinawa, Czechoslovakia or Bulgaria.

On his passport application the appointee listed his permanent residence as Home, Pennsylvania, and gave his mailing address as in care of PAUL R. ABBEY of Home, Pennsylvania. It was noted that he listed this individual as his father who was

born in Pennsylvania in February, 1901, and he listed his mother as MILDHED ROSTLEWAITE, who was born in Indiana during May, 1906. ABBEY recorded that he was last married on August 5, 1950, to JEAN SCHMECHELL who was born in St. Joseph, Missouri, on April 26, 1929, and who at the time of the application was residing at 1815 East Coal in Albuquerque, New Mexico. He indicated that this relationship had not been terminated and the identifying witness to his application was FREDRICK E. BLACK, no relationship, 1228 North Lafayette Avenue, Albuquerque, New Mexico, who had known ABBEY for two years.

The files of the Passport Division also reflect that by letter dated May 11, 1951, the Department of State awarded ABBEY a U.S. Government grant authorized under Public Law 584, 79th Congress, the Fulbright Act. This letter reflected that the appointee had been selected for this award by the Board of Foreign Scholarships on the basis of the recommendation of the New Mexico Committee on State Fulbright Scholarships, and this grant was effective under the 1951 annual program. This award also revealed that ABBEY's permanent mailing address was Tijeras, New Mexico, and that he was to study English literature at the University of Edinburgh for a period of nine months. The Foundation or Commission was listed as the U.S. Educational Commission, 55 Upper Brook Street, London, W.I., England.

This grant approved round trip transportation and maintenance for the grantee without dependents and also set forth that the amount of foreign currency involved would be 468 pounds.

By letter dated May 24, 1951, the appointee requested the Department of State to arrange his schedule in order that he could be in the East of the United States for at least one month prior to his leaving for the United Kingdom. He requested this in order that he could visit several friends and relatives in Pennsylvania and New York and he also stated that he had some business of a more formal nature which necessitated a few weeks in the East. By letter dated June 8, 1951, the Department of State advised the appointee to direct his request to the U.S. Educational Commission in the United Kingdom inasmuch as they were responsible for his arrangements of travel. By letter dated June 20, 1951, the Department of State advised Mrs. JEAN ABBEY with reference to her letter of June 9, 1951, that she could write to the U.S. Educational Commission

In the United Kingdom in the matter of employment in Edinburgh. This letter further pointed out that the grant was in no way obligated to maintain a dependent of a grantee. This letter also set forth that as soon as the appointee received word of a travel reservation he should request the courier to make a reservation for his wife and at the same time advise the courier to bill the appointee for his dependents transportation. It was noted that this letter was addressed to Mrs. JEAN S. ABBEY, Tijeras, New Mexico.

The files of _________,another Government agency which conducts intelligence investigations, contained no pertinent identifiable security information concerning the appointee.

The records of reflected no information identifiable with the appointee's name.

The files of the Netropolitan Police Department, Washington, D.C., reflected no record which could be identified with the name of the abointee.

The appoint o's name was checked against the rectral of the Identification Divipion of the Tederal Bureau of Investigation and no criminal rectra was found.





III. RESULTS OF INVESTIGATION

At Albuquerque, New Mexico

University of New Mexico, reflect that appointee entered the University of New Mexico February 5, 1948 as a transfer from the State Teachers College of Indiana, Pennsylvania. He enrolled in the School of Letters, Arts and Sciences, majoring in philosophy and engineering. Appointee graduated with honors June 4, 1951 receiving a degree.

The records reflect appointee attended Indiana State Teachers College at Indiana, Pennsylvania during 1947 and the first semester of 1947-48. The records reflect he was born January 29, 1927 and his place of birth was not shown. His parent is P. R. ABBEY of Home, Pennsylvania. The records reflect appointee attended the Indiana High School at Indiana, Pennsylvania. The records also reflect that appointee is a veteran, having formerly been in the Army Infantry Service. He entered the service June 22, 1945 as an enlisted man.

The March 14, 1951 issue of the "New Mexico Daily Lobo", a publication at the University of New Mexico, reflects a letter to the editor which is as follows:

In this day of the cold war, which every day shows signs of becoming warmer, the individual who finds himself opposed to war is apt to feel very much out of step with his fellow citizens. As an isolated individual he feels desperately inadequate either to check the tide or to make significant contribution which might serve to remove the occasion of wars. He feels, nevertheless, the essential wrongness of war and is searching for an alternative.

"On the UNM campus such a group—it includes both students and faculty— has formed to discuss the implications and possibilities of resistance to war. This group has no political or religious affiliations. Although not desiring to create an organization, this group feels the need of informal association. Persons interested in associating with us may get in touch with one of the undersigned."

There were sixteen names signed to this letter among whom was appointee.

advised that ABBEY was unknown to him personally. He stated, however, that he was acquainted with the fact that he was a student at the University of New Mexico for two or three years prior to the past academic year. He stated the records of his office reflect that appointee resided in the dormitories located on Kirtland Air Force Base. He stated there was no information in the files of his office which reflects adversely on his loyalty to the United States.

advised that he was acquainted with the fact that appointee was the editor of a literary publication on the campus named "The Thunderbird." He informed that in the spring of 1951 this publication came out with an obnoxious quotation on the front of it which had implications against religion and government. He advised that he recalled the incident and knew that there was an investigation made of it by the head of the Student Affairs Committee on the campus. He stated that it was his impression that the outcome of this investigation seemed to indicate that appointee was a highly intellectual individual who was rather shy and who desired to get his name before the students and create a sensation.

stated that he did not believe there was any motive behind the doing of this thing and that he himself had not associated appointee with any of the Communistic element on the campus at that time.

advised that the records of his office concerning appointee while he was at the University of New Mexico and also concerning his residence in the student house building on Kirtland Air Force Base, contained no information reflecting adversely on his loyalty to the United States. Advised that he had no information concerning the formation of a World Peace Group in which appointee was interested. He stated several groups have mentioned formation of peace groups on the campus but he does not associate appointee with any of them.

advised that she recalls appointee as a student at the University of New Mexico during the period 1948 to 1951. advised that there was

being a potential writer. He mentioned that some publishing company was considering purchasing a manuscript written by appointee. This consideration was between appointee and three others in the United States at the time. The lasso mentioned that appointee had secured a Fulbright scholarship and had spent the year 1951-52 in Scotland.

He stated that following his marriage at Albuquerque, New Mexico it was evident that his individualism might cause a rupture in his marital relations. Appointee and his wife did not get along too well, he being one who desired to follow his creative writing and she being one who desired a home and association with others. Explained that appointee's wife accompanied him to Scotland but returned four or five months later and secured a divorce in Albuquerque. He stated it was purely incompatability on both their parts.

Concerning appointee's loyalty stated that he has no information reflecting adversely on his loyalty to the United States. He mentioned, however, that appointee was connected with an incident at the University of New Mexico while appointee was editor of "The Thunderbird" He described "The Thunderbird" as a literary publication of the students at the University of New Mexico. He referred to the incident concerning the alleged quotation of LOUISA MAE ALCOTT on the front of the publication. He stated that the only thing he could figure out concerning this was that appointee desired to get his name before the student body and he put the quotation there for that purpose only

He stated, nowever, that he believed appointee got more of a reaction out of the incident than he expected and did not seem to want to make any retraction. He stated that because of this he always figured that this momentary publicity had somewhat of an effect on appointee.

advised that appointee connected himself with a world peace movement on the campus at the University of New Mexico during the spring of 1951. He stated it was very temporary and was started by a representative of an organization known as the "Fellowship of Reconciliation." This representative came from Los Angeles, California and associated himself with individuals on the faculty and students who consider themselves pacifists and who are against war in any form. He described appointee as being one of those individuals who is against war although he served during the last world war. He stated the organization was formed or was in its formative stage during the end of the school year of 1951 and he did not believe that it went further at that time. He believes appointee was interested in that organization because of his deep feeling against war in any form.

In conclusion stated again that he did not consider any of the information which he had furnished as reflecting adversely on appointee's loyalty to the United States. He stated he was such an individualist that if he felt a particular way he would be the first individual to be on a soap box in the middle of town expressing his feelings in that respect. He stated that while appointee was on the campus he was not associated in anyway with other students whom thought were members of the Communist Party. He stated appointee was just an individualist who

had his own way of doing things which happened not to be the way the average

person would do it.

He stated appointee was a definite individualist who had great ability in the creative writing field. He pointed out that he received a Fulbright scholarship and went to Scotland during the year 1951-52. He also pointed out that appointee had written a story which if finished would be worthy of publication.

stated that appointee was indiscreet in his individualism in regard to the incident concerning the campus literary publication "The Thunderbird." stated that he was not concerned over this incident particularly because it lit right into what a young promising literary individualist might do in campus activities.

He stated that the novel appointee wrote was the story of one man who tries to live several lives and consequently fails to achieve any genuine kind of life at all. He stated the theme as expressed by appointee is deceptive and betrayal and fraud with variations. The end is an ironic and melodramatic death for the hero in the wilderness maze symbolic of the futile, confused, contradictory, barren waste he has made of his own life.

stated that these are appointee's words as regards the theme and the end of his novel. He described the main character of the novel as extremely repulsive. He stated, however, that he did not feel that the novel was any reflection of appointee's feelings in one manner or another.

advised that it has come to his attention that appointee and his wife had separated since they went to Scotland in 1951. He informed that he did not know of any reason for this.

advised that he has no information that reflects adversely on the loyalty of appointee to the United States. He stated that he is an individualist which many people will not understand but he has no information that would indicate disloyalty in any manner.

advised that he was acquainted with appointee as a student during the time appointee was at the University of New Mexico. He advised that he was not personally acquainted with appointee and knew him only as a student. He stated no information had come to his attention that would reflect adversely on his loyalty to the United States.

advised that he was acquainted with appointee. He knew him as a student at the University of New Mexico

He informed that he knew of no information which would reflect adversely on his loyalty to the United States.



GLENN E. SMILET of Los Angeles, California came to the campus of the University of New Mexico as a representative of an organization known as the "Pellowship of Reconciliation." He stated this organization was a pacifist organization and did not believe in war.

appointee was interested in the same principles and described him as a pacifist. He stated the organization had a few informal meetings toward the end of the school year and no active organization was formed. He stated that none of the individuals on the campus of the University of New Mexico who were generally associated with Communism were associated with this organization. He stated that at least he knew of no such individuals.

mentioned the incident in connection with the publication of the March 1951 issue of The Thunderbird* at the University of New Mexico. He described this incident as one of those things that a young creative writer on a university campus might do at any school. He stated that as far as he knew appointee had no ulterior motive behind the incident whatsoever. He informed that he had no information that would reflect adversely on his loyalty to the United States.

Mr. Abbey registered informally at this Consulate en October 10, 1951 and gave his residence in Edinburgh as 7 Warrender Park Crescent. His wife care to Scotland with him but returned to the United States in December 1951.

Mr. Abbey was a Pulbright student at Edinburgh University in the field of moral philosophy. In addition, he took courses in metaphysics and English. Inc lecturers in moral philosophy and metaphysics remember him being in their classes but he was not a very active student and they formed no particular impressions about him at all. We have not been able to find the person who taught his elase in English. The secretary of the Arts Department of the University has made extensive inquiries to find some faculty member who knew Abbey or who was in any way acquainted with him, but appearently he was not well know: to anyone at the University.

Several American students lived in the vicinity of Warrender Park Grescent when Abbey was there, but none of these had ever heard of him. Since Fulbright students some here for one year at a time, the other Rilbright students who were with Abbey have also returned to the United States.

She seemed to be an intelligent and sincere person who was very willing to tell all that she knew. She said Abbay was writing a book while he was in Edinburgh which took a considerable portion of his time. He was not very concerned about social relations or about his work at the University, but seezed precocuried with his sum line of studies and with writing his book. Abbay's character and integrity were very high indeed. Then he wished to, he could settle down to hard and steady work. She found him mather epinionated, self-centered, and liable to hold strong prajudices. When asked what sort of prejudices, were mentioned an eccasion when Abbey attended a full-dress direct party and returned semembat discayed with the formality of the affair. 



"I don't know anything about his Penn State education and I don't really know what he studied or what activities he participated in but I heard him telling about this incident of attempting to get people to burn their draft cards. That was simply an overt expression of his being against peace-time conscription. He is against peace-time conscription, I know. He is not against war-time conscription. He, of course, along

"with the greater majority of the rest of us, prefers not to have any conscription whatsoever when we have no necessity for it. He would defend his country and that action at Penn State through the burning of the draft cards ---- I don't think it actually materialized, but I feel that was probably one of his wild notions, as he has had in the past, such as this publication 'The Thunderbird' where he says 'men will never be free until the last king is strangled with the entrails of the last priest' and attributing that to LOUISA MAY ALCOTT. I think this article was written by VOLTAIRE. That quotation was taken from the area around the French Revolution or rather the Protestant Revolution, when Protestantism was being formed as a branch of the Catholic Church. Of course the French Revolution was tied in with that as well as the Social Revolution.

"He applied for a scholarship while he was in his Senior year at Penn University. That was the Fallbright Scholarship which was given to him on the recommendation of I believe Dr. C. B. WICKER. He went to Scotland to study philosophy in Edinburgh. During the time that he was there he made extensive travels over Europe.

I think this is quite a long and involved philosophical term that he attaches to his beliefs and ideas. A liberal Democrat would be a simpler way to put it, and yet we do have these contradictions coming back. A complete cross to what he would purport in one moment. I think there is no question as to his loyalty to this country. I think there is no question of his being involved with any subversive organizations. He never made any effort to contact such an organization as far as I know. I know of no mention, and I know I would of such an organization, if such existed.

I know of no organizations that have tried to contact him. Probably the closest to it, if this little movement up here at the University wasn't Communist inspired, this Pacifistic meeting that took place during his last year at the University, I believe it is 1951, during that time that could have been a Communist inspired or Communist promulgated meeting, but it was simply directed against war, etc.

think probably a good many of us could be misled by an organization like that. I know in looking through lists of organizations, there probably have been times that they have come around to your door saying I am with the Americans for the freedom of the Czechs or the Americans for the freedom of this, that or the other and asked for contributions. That was probably the closest helps ever come to being associated with a Communist backed organization.

I am making these observations simply to prevent ABBEY from being wrongfully maligned. I think that a good many of his statements were simply made in the heat of argument and discussion. He is writing a book that is to be published by DODD and MEAD and he is writing that in his spare time. If the Security Commission goes ahead with the investigation it might possibly be that he would be dismissed from his job here and I know that is his only means of support. I think he probably works three days a week at the Quality of Water Department. The boy would be rather hard pressed to find another job where he could work enough to put himself through this period of writing. He has signed a contract with DODD and MEAD and right now it is rather vital to him that he has some peace of mind in order to continue his writing of this novel. The name of the novel is JONATHAN TROY."






