Since the time of our last communication regarding this matter, Domestic Security/Terrorism investigations have been initiated on Illinois Knights of the Ku Klux Klan, Los Angeles Area Skinheads, Aryan Women's League, and Texas Reserve Militia. Enclosed are separate memoranda outlining elements for each of these groups, as well as updated memoranda regarding other groups which continue to be the subjects of Domestic Security/Terrorism investigations. Although these memoranda are not classified, they do contain sensitive information. 


