(U) ON MARCH 15 JULIO SIMON, AN EX-POLICE OFFICIAL BEING INVESTIGATED FOR HIS POSSIBLE INVOLVEMENT IN THE DISAPPEARANCE OF JOSE AND GERTRUDIS POBLETE (SEE REFTEL), WAS TRANSPORTED FROM THE PRISON WHERE HE IS BEING HELD FOR THE KIDNAPPING OF THE POBLETE, S DAUGHTER CLAUDIA, TO THE COURTHOUSE WHERE HE WAS SCHEDULED TO PROVIDE HIS STATEMENT (DECLARACION INDAGATORIA). THIS DECLARATION CANNOT BE TAKEN WITHOUT THE PRESENCE OF THE DEFENSE ATTORNEY, AND SINCE SIMON'S ATTORNEY DID NOT SHOW UP FOR THE HEARING, FEDERAL JUDGE CAVALLO ORDERED SIMON BACK TO DETENTION. SAENZ WAS SCHEDULED TO TESTIFY ON MARCH 15, BUT HE DID NOT APPEAR IN COURT AS SCHEDULED GIVEN MEDICAL REASONS. SCHIFFER DID TESTIFY AND HAD PREVIOUSLY TESTIFIED IN MAY 1999. THE COURT ALSO INTENDS TO HEAR TESTIMONY FROM CIVILIANS, SUCH AS NEIGHBORS AND DOCTORS WHO SIGNED THE DEATH CERTIFICATES OF THE DISAPPEARED, AS WELL AS TWO PEOPLE WHO HAD BEEN DETAINED AT THE DETENTION CENTER AND A FAMILY MEMBER OF A DISAPPEARED.
