On December 24, 1980, a source in a position to furnish information from Western Union Company, Miami, Florida, 801 S.W. 1st Avenue, Miami, Florida, advised he would be unable to furnish information concerning a telegram sent by Mr. Gibb until he checked with his office in Brighton, Iowa. He also stated, due to the holiday traffic in telegrams, he would have to wait until December 29, 1980, in order to obtain information concerning the telegram. The source advised at this time that the telegram was phoned in from a Miami telephone and was switched, due to the heavy traffic, to their Iowa Office to be transmitted via RCA to London from New York City.

On December 29, 1980, the source in a position to furnish information concerning Western Union Company, Miami, Florida, advised the bill for the telegram sent to London by Mr. Gibb is to be paid for by Robin Gibb, 5242 North Bay Road, Miami, Florida 33140, billing the telegram to telephone number (305) 864-2373.

Miami has been unable to determine the present location of Robin Gibb without making direct contact with the Bee Gee rock group at this time. Since the [redacted] requested Mr. Gibb not be contacted, Miami is assuming the Bee Gee rock group is presently in Miami, Florida.

RE: ROBIN GIBB

On December 9, 1980, [redacted] contacted the New York Office of the Federal Bureau of Investigation (FBI) and advised that he and his partner, [redacted], are attorneys who represent [redacted] in divorce proceedings against subject, Robin Gibb. Robin Gibb is a member of the BeeGees singing group. [redacted]' office is in New York, New York, and [redacted] office is in London, England. [redacted] advised that he and [redacted] have received numerous threatening telegrams from Gibb which threatened their lives. All telegrams were allegedly sent from Miami, and [redacted] advised that Walters has reported this matter to the local authorities in London.

[redacted] was requested to furnish copies of the telegrams to the FBI in New York; however to date, the two enclosed telegrams are the only ones furnished. It is noted that the telegram received at New York does not contain a threat which meets the requirements for any prosecution for extortion.

On December 17, 1980, Agents of the New York Office attempted to interview Robin Gibb who was temporarily in the New York area at the time. Agents were referred to Gibb's attorney, [redacted], of the firm Rose, Field, and Gitomer, 88 - 7th Avenue, New York, New York.

On December 18, 1980, [redacted] was contacted and advised of instant investigation. [redacted] stated that his client would not be foolish enough to carry out any threat especially in view of his singing career. [redacted] advised that it is his opinion that [redacted] and [redacted] are attempting to use the FBI to embarrass Gibb and to bring pressure on him in the divorce proceedings.

On February 23, 1981, [redacted] Security Director, Southern Bell Telephone and Telegraph Company, advised he would be unable to furnish the subscriber to telephone number [redacted] without a subpoena.
