Dear Mr. Greenewald:

This is the final response to your July 10, 2009, Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS)/Federal Emergency Management Agency (FEMA). You requested a copy of the FOIA case log for the calendar year 2008. This office received your request on July 16, 2009.

We have considered your request under the Freedom of Information Act, 5 U.S.C. § 552. We conducted a search of the Office of Records Management for documents responsive to your request that produced a total of 74 pages. Of those pages, I have determined that 11 pages of the records are releasable in their entirety, and 63 pages are partially releasable pursuant to 5 U.S.C. § 552(b)(6).

We have enclosed a copy of the documents to be released in response to your request. Any redactions are accompanied by the corresponding FOIA exemption:

FOIA Exemption 6 exempts from disclosure personnel or medical files and similar files the release of which would cause a clearly unwarranted invasion of personal privacy. This requires a balancing of the public's right to disclosure against the individual's right to privacy. The privacy interests of the individuals in the records you have requested outweigh any minimal public interest in disclosure of the information. Any private interest you may have in that information does not factor into the aforementioned balancing test.

You have a right to appeal the above withholding determination. Should you wish to do so, you must send your appeal and a copy of this letter, within 60 days of the date of this letter, to: Associate General Counsel (General Law), U.S. Department of Homeland Security, Washington, D.C. 20528, following the procedures outlined in the DHS regulations at 6 C.F.R. § 5.9. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS regulations are available at www.dhs.gov/foia.

Provisions of the FOIA allow us to recover part of the cost of complying with your request. As a courtesy, FEMA will not charge the fees incurred in the processing of this request.
