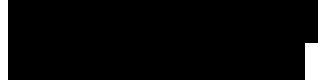

Dear Mr. Greenwald:

This letter responds to your FOIA request dated February 17, 2017. You requested the Health Resources and Services Administration's (HRSA) FOIA case and appeal log for the years 2000 through 2016.

A records search was conducted in the FOIA office and a FOIA log was produced, which includes information from 2012 through 2016. HRSA's FOIA office was only able to locate the log dating back to 2012 because earlier records were destroyed pursuant to General Records Schedules (GRS), which provides for mandatory disposal authorization for temporary administrative records. Additionally, HRSA's FOIA office does not maintain a log of appeals, as we do not process appeals.

Enclosed you will find a spreadsheet with the information requested. However, I have determined to withhold minor portions of this spreadsheet under FOIA Exemption (b) (6). Exemption 6 protects information the disclosure of which would constitute a clearly unwarranted invasion of privacy. The withheld information consists of information that would identify requesters who are seeking personal records regarding himself or herself.

There will be no charges in this instance because the billable costs are less than our threshold of \$25.

If you believe that the information withheld should not be exempt from disclosure, or this response constitutes an adverse determination, you may appeal. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision.

Your appeal must be mailed within 90 days from the date of receipt of this letter, to:
