


Dear Mr. Greenwald, Jr.

We received your Freedom of Information Act (FOIA) request dated 13 September 2012. Your request was assigned USNORTHCOM FOIA case number FY12-14SEP2012-NNC62. In your request letter you asked for the following: FOIA case logs for the calendar years 2010 and 2011.

After performing a search of our systems of records we found Fiscal Year 2010 and Fiscal Year 2011 FOIA case logs. Upon review of the responsive documents (Attachment 1) we have determined them to be partially releasable and therefore exempt from disclosure under FOIA exemptions (b)(5) and (b)(6). The authority for this exemption is 5 USC 552 (b)(5) and (b)(6).

If you are not satisfied with our command's response, you may administratively appeal to Mr. James Hogan, Chief, Policy, Appeals and Litigation Branch, Office of Freedom of Information, 1155 Defense Pentagon, Washington DC 20301-1155. Your appeal should be postmarked within 60 days of the date of this letter, should cite our case number FY12-14SEP2012-NNC62, and should be clearly marked "Freedom of Information Act Appeal" on the request.
