Dear Mr. Greenewald:

This letter is in response to your U.S. General Services Administration (GSA) Freedom of Information Act (FOIA) request number (GSA-2017-001452), submitted on August 5, 2017, in which you requested the following:

"[a] copy of records, electronic or otherwise, of the following: all documents, emails etc. that pertain to the vacating by the Secret Service, of Trump Tower, in Manhattan, New York. Please include all records that pertain to this."

Enclosed please find the documents responsive to your request.

In processing your request we have withheld identifying and contact information for law enforcement agents/officers in accordance with the sixth and/or seventh exemption of FOIA, 5 U.S.C. § 552(b)(6) and(b)(7)(C), because public disclosure of this information would constitute a clearly unwarranted invasion of personal privacy.

Additionally, GSA withheld confidential/or proprietary financial information pursuant to the FOIA, 5 U.S.C. § 552(b)(4). The fourth statutory exemption permits an agency to withhold "matters that are trade secrets and commercial or financial information obtained from a person or organization, that are privileged or confidential" and which, if released, would result in competitive harm to the company.

Finally, GSA withheld information showing building plans / sketches have been redacted pursuant to the FOIA, 5 U.S.C. § 552(b)(5); as this information is related to the deliberative process associated with planning for building security.

As we have redacted information referenced in the above paragraphs with the aforementioned FOIA exemptions, this technically constitutes a partial denial of your FOIA request. You have the right to appeal the denial of the information being withheld. You may submit an appeal online at the following link (https://foiaonline.regulations.gov/foia/action/public/home) or in writing to the following address:

Your appeal must be postmarked or electronically transmitted within 120 days of the date of the response to your request. In addition, your appeal must contain a brief statement of the reasons why the requested information should be released. Please enclose a copy of your initial request and this denial. Both the appeal letter and envelope or online appeal submission should be prominently marked, "Freedom of Information Act Appeal."

GSA spoke with the Trump Organization(TO) attorney yesterday (5/9/17). The Trustees for the Trump Tower (TT) have not decided whether they will comply with the Representation and Certifications document just yet; (b) (5)

As such, GSA asked them to allow continuance of the procurement process while this issue is being reviewed at the W.H. GSA does not need the Representation and Certifications document completed until right before award. By allowing GSA/ USSS to continue with the procurement, once a decision is made to award, the only remaining action would be to register TT in SAM, which only takes a few days. The attorney indicated that TO will get back to GSA; timeline unknown. GSA will follow up again this morning.

In the interim, in an effort to quickly pivot in case the (b) (5) decision does not turn in our favor, is to determine whether or not you can move into another location outside of the TT. (b)(5)
