2. QUOTE UPON REVIEWING THE TRANSCRIPT OF MY APPEARANCE ON MAY 16, 1973 BEFORE THE SUBCOMMITTEE OF THE COMMITTEE ON X APPROPRIATIONS, I NOTED THAT THERE MIGHT BE SOME QUESTION ABOUT MY DENIAL ON PAGES 271 AND 272 THAT I HAD EVER DISCUSSED ASSISTANCE TO HUNT WITH EHRLICHMAN, YOUNG, OR HALDEMAN. MY DENIAL WAS DIRECTED AT THE TIME FRAME (JULY AND AUGUST 1971) WHICH I THOUGHT WAS IMPLICIT IN MY COLLOQUY WITH CHAIRMAN MCCLELLAN. I DO, THEREFORE, WANT TO MAKE IT A MATTER OF RECORD THAT I DID PARTICIPATE IN A MEETING WITH EHRLICHMAN AND DEAN ON DECEMBER 15, 1972. THE DETAILS OF THAT MEETING ARE COVERED IN A MEMORANDUM FOR THE RECORD
