Dear Mr. Greenewald:

This is a follow-up response to your Freedom of Information Act (FOIA) requests for Intellipedia category pages "NEW AGE" (FOIA case 79192) and "PSYCHIC POWERS" (FOIA case 79195). On 3 February 2016, we sent you a letter in response to your appeal of our initial finding of no responsive documents. In that letter, we denied your appeal and upheld our original findings of no responsive documents.

We have since discovered that a responsive document was located for case 79195, but was overlooked due to an administrative error. This document is enclosed. For your information, we have also enclosed a copy of the results page for the requested topic in case 79192, which indicates a category entitled "NEW AGE" does not exist. Certain information, however, has been deleted from the documents.

This Agency is authorized by statute to protect certain information concerning its activities (in this case, internal URLs). Such information is exempt from disclosure pursuant to the third exemption of the FOIA, which provides for the withholding of information specifically protected from disclosure by statute. The specific statute applicable in this case is Section 6, Public Law 86-36 (50 U.S. Code 3605). We have determined that such information exists in these records, and we have excised it accordingly.

Since these deletions may be construed as a partial denial of your request, you are hereby advised of this Agency's appeal procedures. You may appeal this decision. If you decide to appeal, you should do so in the manner outlined below.


- It must be postmarked no later than 60 calendar days of the date of this letter.


