Dear Mr. Greenewald:

Thank you for your 23 August 2017 letter appealing the response from the National Security Agency (NSA or Agency) to your request under the Freedom of Information Act (FOIA) for "a copy of records, electronic or otherwise, of the 'STATISTICS' page for the Intellipedia system. Please include the page(s) that include the number of entries currently in the Intellipedia system, the page views, the number of visits, etc." NSA reviewed the responsive material to your request and partially denied its release.

I have reviewed your initial request, the Agency's 31 July 2017 response to you, and your letter of appeal. Based on my review, I have determined that certain information will be released to you on appeal. Accordingly, we will produce these non-exempt, responsive portions to you. See the enclosures. However, certain information continues to be withheld pursuant to the third<sup>1</sup> exemption of the FOIA as noted below. Your appeal is therefore partially denied.

You are hereby advised of your right pursuant to 5 U.S.C. § 552(a)(4)(B) to seek judicial review of my decision in the United States District Court in the district in which you reside, in which you have your principal place of business, in which the Agency records are situated (U.S. District Court of Maryland), or in the District of Columbia.

Additionally, you may contact the Office of Government Information Services (OGIS) at the National Archives and Records Administration to inquire about the FOIA mediation services


