SUBJECT: Contect Report Setween "Justo" and Mr. Micks (using name Cal Mitch) on 22, 25, 27, 28 and 29 September 1961.

- 1. In addition to the subject name, Hr. Pekich (using name Jim Bowdin) was at all mactings and one or all of the following individuals also attended those meetings:
 - a. Andres ZAYAS ("Justo")
 - b. Lais SANCHEZ ("Piccolino")
 - c. Tony HARZ ("Tony")
 - d. Angel ROS ("Cullin")
 - c. Wilfredo BRITO ("Bebo") using nero E. I. Rarrison
 - f. Formendo CABADA using name Frank Dutton
- 2. For additional details already reported by cable, see DIR 15354 (OUT 53207) dated 2 October 1961.
- 3. According to BRITO the leadership of the UR as of 17 April 1961.
 was as follows: ("Rafael" had been national coordinator until executed.)
 - a. "Justo" civilien coordinator.
 - b. "Cesar" action coordinator.
 - c. "Picceline" general coordinator.
 - d. "Piccoline" right-hand men of "Rafeel" (also known as "Podro").
 - e. "Arturo" intelligence.
 - f. "Debo" (true name: Wilfredo BRITO) propaganda.
 - g. "Ricardo" security.
 - b. "Bilerio" como.
 - 1. "Marcial" transportation.
 - ij. "Bebo" (not the same as the above "Bebo") finance.

k. "Frank" - public rolations.

1. "Bob" - not a member of the official executive committee but attended all the meetings.

(Note: At a later meeting "Justo" said a men called "Ricardo" (true name: Sierge PYENTEPRIA) was the eo-called UR leader on the street and "Ricardo" (emother men, true name: Ricardo RODRIGUEZ-ESPADA) was the UR leader inside the Italian Embassy.)

- 4. "Cosar" was the member of the UR that the U/T operator, Al MENDOZA, using Signal Plan SULTAG, contacted. Luis and BRITO said MENDOZA was a crary boy. When they say him they got penicky.
- 5. "Justo" somitted getting ten thousand posos from Miro CARDOMA. However, first BRITO said be did not get it until corrected by "Justo".
- 6. Although "Justo" lived in the Italian Embassy he said he did not take asylum but rather used that as a safe operations base and was in and out many times conducting UR business. He finally admitted, however, that in the eyes of the Cuben people that was probably asylum.
- 7. The following groups and their leaders and the Embassies in which they took anylum was given by BRITO:
- a. MRRC "Cuilin" Italian Embaney. This is a different men then "Simone" was the men who was the leader of the MRRC until "Cuilin" returned to Cuba (believed to be March, 1961) and again took over the MRRC.
 - b. MRP Mercos Williams Italiam Embassy.
- c. UR "Justo" Italian imbassy. (He said this was not asylwa for himself, but just a safe living area.)
- d. EDC "Lucas" Italian Embassy. (They don't like "Lucas"; went to work with AMBLESS-1 as leader of HDC.)
- e. DRE "Leciano" Embassy, if any, not known. (WITELL supposedly new loader of DRE.)
- f. RESCATE "Derio" Embassy, if any, not known. (They don't like him.)
- g. 30th of Hovember VILLAREAL (trus name). (They say you never know who the real leader of the 30th of Hovember is, for it has a thousand groups and a thousand leaders.)

- 8. "Quilin" supposedly organised the MRR back in 1959; then he had a falling-out and his element, known as the MRRC, supposedly broke with the MRR several months before the invasion and worked with the UR. However, all of them spoke well of "Francisco" and admitted that his group carried out most of the action but always adding along with the UR. It soon become apparent that with "Francisco" gone and the evident confused leadership of the MRR, that "Guilin" thought this would be the opportune time to attempt to regain control of the MRR. Since he did not feel be could claim the MRR as such, he attempted to do it by saying "All the good man left the MRR and now belong to him".
- 9. Hereos Williams was the action leader for the MRP and left because he wanted action and couldn't get it with RAY. He had orders from RAY not to use explosives, etc., and not to expose themselves; but, to just lie low and let the others take the risk. Marcos didn't agree with this and felt that the MRP was going to have to be active also.
- 10. They knew of AMTUG-1 using the warness "Andres" and also knew the true identity, and they denounced him and "Cesar". (However, this was not "Justo" talking, but was BRITO and SANCHEZ; said, BRITO freely schaitted that "Justo" did not feel the same way about "Cesar" as he did.) SANCHEZ, in addition to knowing AMTUG, knew of an "Ermesto", but did not know his true identity (this was the warness used by AMCOAX-1).
- Il. When querying about some of the names in the newspaper erticle that emmonsed the arrest of twelve people, TORRADLLA was an excellent man; PUJAL, who was a distant cousin of BRITO, was an excellent man. Although they didn't like AMPUG-1 because they felt he was trying to split the UR in his attempt at unification with "Coear" (again "Justo" did not seem to believe this about "Coear"), they said AMPUG would never talk. "Coear", BRITO felt, was weak and indicated he might talk, however, "Justo" was so violently opposed to that, that BRITO finally admitted that "Coear" wouldn't talk; it was just that he didn't like him and thought he was no good. Moet of the other individuals they didn't know or had no opinion of. However, one of them seemed to think that GARCIA-RUBIO might have talked, but this seemed to be based more on the fact that he knew of many of the events and was a loose talker and indiscrete Tather than the fact that he arm deliberately informed for his own bonefit.
- 12. "Year" was bragging about knowing of "Brand", GARCIA-RUBIO, and PERIOR W/T messages. It was later learned through "Justo" that "Tony" got his information from AMTUG-1 and GARCIA-RUBIO estually lived in "Tony's" house and may have operated his radio from there.

- 14. A Paul Burns was named as the man representing the outfit and a mamber of the American Embassy in Moveme until June, 1960. He supposedly was in Santingo in 1959.
 - 15. The following is a statement written by "Tony":
- "I, Luis Antonio DIAZ Pine, gave the 24th of December 1960, at the U.S. Embassy in Havene, Case, to Mr. an envelope with the following contents: A photoweric copy of the Revolutionary Unity original document, a leaf of paper of 8" x 11" with some addresses, a half leaf of paper of about 6" x 44" cut in half, and four \$100.00 dollar bills. This envelope was addressed to Fred COUDIE, at Mismi. I never got in touch with because when I got to call him at Mismi, we was called back to Caba en account of the relation rupture between the U.S. and Caba. Refeal DIAL told me that he got the envelope he sent, but he didn't wice. He asked wife and she didn't know a thing about it."

- 16. Attachment A is a copy of a document, self-explanatory, submitted by SGS.
- 17. He commitments were made to these people rather, it was a matter of listening to their ideas and feelings and getting them in a frame of mind to get down to real business after being cent back to the MAVE area. They were told they would deal with a Mr. Peters and all business including training would be handled through him. They appeared to be in an eager and receptive smod when they were ready to leave Washington the afternoon of 29 September. They indicated a willingness to cooperate with the PRA, that is, "Ower" and "Houty", and further indicated that "Bobo" ACCSTA would be an problem; that they would deal with the "Antonio"-Ignesio MZHDOZA MEP complex. In lies of Marcas Williess, ROS would either just represent the MREC or might even fell back as a part of the Ca. The relations with the other major groups would be much the same as advocated by AMODAX-1, consequently, it is felt that this is a chance to facilitate AMMAN-1's effort at producing a united resistence. They all indicated a willinguase to return to Cube if they could be guaranteed a firm support, but they did not want to go back to Caba just for the sahe of returning and they did not went to risk the lives of their man unless they felt sure there was a definite goal to be attained. "Justo" sepecially, felt very strongly that support must come through

one command channel for all groups rather than to individual groups. At the same time, he recognized that for security sake this would have to be bandled on a compartmented basis.

18. They were told that they must make an attempt to got along with Mire CARDNA and even though they may not like him they must try to acceptate with him and work with him and/or have him work for them rether them fight him. They must not lock horse with him, however, after attempting to work with him if they found it completely impossible to would not dony them support because of this.
