1. VIA LICARI WILL BRIEFLY AMDIP-ONE AND UD-ONE RRP SITUATION AND TRY TO ARRANGE LETTER TO AMUD-ONE FROM MEXICAN PRESIDENCY. CAN ANTICIPATE SIMILAR SITUATION OTHER COUNTRIES THUS WILL STRESS NEED FOR EARLY AMUD DECISION ON OFFICIAL RRP FOR EACH COUNTRY OF SUITABLE STATUTE TO HEAD CUBAN END AFTER OVERTHROW.
2. MATTERS OF PLANS WITH AMUD FOR SEIZURE DIPLOMATIC FILES MEXI AND OTHER COUNTRIES ENCL COULD BE HANDLED SEPARATE CABLE TO WAVE.
3. FOR MEXI: YOU WILL BE ADVISED SOON AS DECISIONS REACHED ABOVE MATTERS.
