1. AMIRON SHOULD NOT PICK UP ANY GARCIA PERSONS REF. PAYMENTS TO DEPENDENTS OF NON-RETURNED GARCIA PERSONNEL WILL BE MADE BY GARCIA SAME SCALE SAME LENGTH OF TIME AS SIMILAR CATEGORY AMIRON PEOPLE.
2. NO FUNDING TO GARCIA ON OR NEAR JULY 10. GARCIA GIVEN ADVANCES IN PAST TO COVER SHIP OPERATING COSTS INCLUDING SALARIES AND BONUSES. JUNE DEPENDENT PAYMENTS MADE FROM THESE ADVANCES AND WILL BE INCLUDED IN GARCIA'S JUNE ACCOUNTING TO US. NO SPECIFIC ADVANCE MADE FOR JUNE DEPENDENTS. SCHNEELOCH MISINFORMED.
