FOLLOWING IS LIST OF NOTICE WHICH OFFICE OF CHIEF ODYKE REQUESTED AMBUD-ONE TO RELEASE ON 15 JUL: RETURNERS AND THEIR DEPENDENTS WILL RECEIVE AUG PAYMENT, WHICH SOMEWHAT SMALLER THAN JUL PAYMENT (MTI \$100) FROM HCR. IN ORDER QUALIFY FOR PAYMENTS AFTER AUG RETURNERS MUST PROVE FINANCIAL NEED AND ESTABLISH ELIGIBILITY FOR ASSISTANCE BY REGISTERING AND FILING APPLICATION AT NEW CUBAN REFUGEE EMERGENCY CENTER MIAMI. AMOUNT MONTHLY PAYMENTS TO RETURNERS WILL BE DETERMINED SAME BASIS AS FOR OTHER CUBAN REFUGEES. RETURNERS MUST BRING THIS NOTICE TO CENTER FOR PURPOSES IDENTIFICATION. INTERVIEWS WITH RETURNERS WILL BE SCHEDULED ALPHABETICALLY ON BASIS SURNAME 24 JUL THRU 18 AUG. (NOTICE LISTS DATES FOR SPECIFIC ALPHABETICAL GROUPINGS)

2. THE ABOVE RELEASE HAS NOT BEEN MADE BY AMBUD-ONE AND WE LEARNED MEANWHILE THAT A MEETING WITH CHIEF ODYKE WAS REQUESTED BY AMEUD-ONE AND AMDIP-2 ONE AND IS TENTATIVELY SCHEDULED FOR 19 JUL. IT IS PROBABLE THAT AN APPEAL OF THIS DECISION RE PAYMENTS TO RETURNERS IS ON THEIR AGENDA FOR THIS MEETING. WILL ADVISE.

3. KUBARK PAYMENTS TO DEPENDENTS OF NON-RETURNERS WILL PROBABLY BE TERMINATED NEAR FUTURE WITH LUMP SUM PAYMENT. MEANWHILE PAYMENTS WILL CONTINUE PRESENT RATE UNTIL DECISION REACHED HOW BEST HANDLE TERMINATION.

4. RE PROBLEMS CIVIL BUDGET PER KEP C, WE NOW PROPOSE REVISION FROM \$151,000 TO \$100,000 FOR AUG. FROM THIS AMOUNT AUG AMINCH SALARIES COULD BE PAID AND REDUCTIONS MADE IN CATEGORIES OTHER THAN PERSONNEL. IT IS HOPED THAT CHIEF COORDINATOR WILL DISCUSS REDUCTION THIS BUDGET WITH AMBUD-ONE AND AMBUD-TWO AND WE WILL ADVISE YOU WHEN WE LEARN OUTCOME THIS MEETING. ANY EVENT WE CONCUR NEED TO HANDLE PERSONNEL REDUCTION IN MANNER TO ALLOW ADEQUATE NOTICE ALL CONCERNED.

## END OF MESSAGE

\*Concerned WAVE request that AMBUD-1 issue a notice advising return recruits that Jul would be last month they would receive payment from FRD that beginning Aug they would be paid \$100 by HEW. Requested HQs cable WAVE text of such a notice which Pres Kennedy had reportedly requested AMBUD-1 to sign. \*\*Concerned dependent payments to non-returned Strike Force personnel and said solution would probably be lump sum terminal payment in amount yet undetermined. \*\*\*Asked if KUBARK planned make no civil section payments including FRD salaries after Jul; if so, personnel should be notified at once; asked who would release notice.
