1. AMBUD AND WAVE AWARE SINCE LATE APRIL CONSIDERATION BEING GIVEN TO TRANSFER OF RESPONSIBILITY FOR SUPPORT OF TRAINEES AND THEIR DEPENDENTS FROM KUBARK TO HEW. UNCERTAINTY CONCERNING AVAILABILITY KUBARK FUNDS FROM MONTH TO MONTH MENTIONED PRACTICALLY ALL DISCUSSIONS WITH AMBUD-1 IN WAVE.
2. ACCORDINGLY DECISION REFC COMES AS SURPRISE TO FEW OFFICIALS ALTHO WAVE CORRECTLY POINTS OUT MAY CAUSE REAL HARDSHIP ON FAMILIES WHO NOT ALREADY ON HEW ROLLS DUE POSSIBLE TIME LAG IN ESTABLISHING ELIGIBILITY.
3. HQS WOULD ANTICIPATE CONSIDERABLE EFFORTS TO PRESSURE KUBARK INTO CONTINUING PAYMENTS FROM THOSE WHO RELUCTANT ACCEPT CUT FROM KUBARK SCALE TO HEW SCALE APPLICABLE TO OTHER CUBANS LESS FAVORED AND TO AMERICANS.
4. SINCE DEFINITE CUT-OFF DATE NOT COMMUNICATED TO RECIPIENTS OF PAYMENTS, HQS APPROVES PAYMENT TO ALL PRIOR RECIPIENTS THROUGH JULY. PAYMENTS BEYOND JULY TO DEPENDENTS OF RETURNEES WILL NOT REPEAT NOT BE KUBARK RESPONSIBILITY. THESE RECIPIENTS SHOULD BE ADVISED IMMEDIATELY

5. DUE DIFFICULTY OBTAIN ADDITIONAL FUNDS FOR PAYMENTS TO RETURNEES.  
FOR JULY, WE WILL NOT BE ABLE TO FUND BEYOND \$501,000 TRANSFERRED TODAY  
UNTIL ABOUT 14 JULY. SUGGEST AMTIKI-1 MAKE PARTIAL PAYMENT TO ALL PAYEES  
STATING THAT BALANCE WILL BE SENT ABOUT 15 JULY.

6. \$501,000 SENT THIS AFTERNOON. WILL BE IN AMTIKI-1 ACCOUNT BY  
COB TODAY.

C/S Comments:

- \* Detailed policy guidance for bonus payments to all Cubans.
- \*\* WAVE(2) authorized to fund AMTIKI/1(4) locally \$ 75,000. Also authorized to make June payments to dependents of Freedom Fighters. Decision on July and subsequent dependent payments would be a matter of high level policy.
- \*\*\* July payments to be made only to dependents of strike force personnel captured or missing.
- \*\*\*\* Cutback in payments would inevitably carry grave political consequences. WAVE(2) urged continuation at least long enough to allow 30 days notice to those slated for cut off.
