Advised "per discussions Passovoy" portion of unobligated funds (\$33,800) would be used to defray PRD Prop Commission for Oct pending final decision continuance that commission, and that balance of such funds not presently committed. Para 2 said AMTIKI-1 survey reveals 10 recruits, now among missing captured, have never drawn "dependency payments"; that effective Sept "dependency payments paid behalf men and deposited trust account against future claims" and that AMTIKI-1 requested that funds "for back payments these wen" be made available for deposit trust account in amount of \$18,375.00, which amount could not be squeezed from unobligated funds now on hand.

Advised no additional KUHARK funds would be furnished for payments to large number of returness claimed by AMTIKI-1 and AMBUD-1 to have received no dependents payments and commented in detail on reasons why request appeared to be no more than attempt by AMBUD/AMIROR to obtain additional funds for political patronage purposes.
