1. ASSOCIATION OF AMGUD BY AMGUD HAS CREATED AREAS OF BUDGETARY CONFUSION WHICH HEADQUARTERS DESIRES ELIMINATE. TO THIS END REQUEST PARAVOY ASK AMGUD-1 FOR BUDGET MEXI DELEGATION AND HIS PLANS FOR VENUE TWO. AMGUD-1 FREQUENTLY HAS EXPRESSED WITH THAT FUNDS FOR ALL EXILE ACTIVITIES BE DISBURSED THROUGH HIM. INSOFAK AS AMGUD AFFILIATES ARE CONCERNED HEADQUARTERS ENDORSES THIS PRINCIPLE, AND ASKS HE WILL PAY SALARIES OF ALL OVERSEAS DELEGATES, INCLUDING MEXI, FROM BASIC ADMINISTRATIVE BUDGET. SUPPLEMENTARY FUNDS ~~WILL~~ ^{SHOULD} BE PROVIDED FOR COSTS OF OPERATIONS WHEN APPROVED BY HEADQUARTERS. THIS APPLIES TO OPS UNDERTAKEN BY OVERSEAS DELEGATIONS WHICH SHOULD SUBMIT PROPOSALS TO AMGUD FOR SUBMISSION ~~FORWARD~~ VIA PARAVOY.

2. AFTER AMGUD-1 AGREEMENT OBTAINED ON ABOVE PROCEDURES REQUEST WAVE ADVISE MEXI NAMES OF MEXICAN DELEGATION AND COORDINATE WITH MEXI RE TIMING OF INITIATION FUNDING BY AMGUD AND PROVISION OF TERMINAL PAY FOR THOSE DROPPED.

3. FOR MEXI: AFTER RECEIPT AMGUD ROSTER ADVISE IF ANY PLANS FOR INDEPENDENT USE OF PERSONNEL DESCRIBED BY AMGUD.


