19 hospital days

316.60 77.40

Admitted April 14, 1962. Patient stated old fracture left tibia. Patient was ambulatory, heart and lungs negative. Discharged April 15, 1962.

Re-admitted April 16, 1962, chief complaint slight swelling and pain right ankle. Patient has history of fractured lower part right leg (by shot gun) one year ago. Was treated at that time by casting the leg for six months. X-rays and lab work done and treated medically. Osteoporosis of the distal one third of the tibia and foot. Patient discharged May 3, 1962 and returned to clinic for medications etc. Patient discharged from clinic.

12 hospital days

415.00 14.60

Admitted April 14, 1962 for examination and observation. Discharged April 15, 1962. Examination revealed Neuroma and severance of right ulna nerve as result of gun shot wound. Patient went to Detroit.

Patient returned to Miami and was readmitted July 12, 1962 for malfunction of arm and hand and taken to surgery for exploration right radial nerve and suture under general anesthetic. Discharged July 24, 1962 and being followed by the Doctor in his office.

7 hospital days

Admitted April 14, 1962. Epilepsy. Patient has history of encephalitis. Lab work done, x-rays taken and treated medically. Discharged April 21, 1962 and returned to the clinic for medications. Doctor following case in his office.

3 hospital days

Several clinic visits for lab work, medicines and x-rays. Admitted May 6, 1962 with infected tonsils. Performed T & A and discharged May 9, 1962 and returned to clinic for further medication. Patient discharged from clinic.

62 hospital days

Admitted April 14, 1962 for examination and observation. Discharged April 15, 1962. Re-admitted April 17, 1962 for further examination and observations and discharged April 22, 1962.

Re-admitted May 3, 1962 chief complaint supuration of left lower leg. About 1 week prior drainage began spontaneously. Sequestrum right tibia done and patient was discharged June 28, 1962. He returned to clinic for medication and treatment and is still a clinic patient.
