1. QUSPORT 1 REPORTED FOLL INTERESTING SIDELIGHTS FROM
 AMLASH 2.

A. BEFORE STORY OF AMLASH 1 ARREST ANNOUNCED, A 2
 RECEIVED CALL FROM TONY LOPEZ, CUBAN EMB CODE CLERK, INVITING A 2
 TO EMB FOR TALK. CHARGE D'AFFAIRES CALZADILLA TOLD A 2 MININT
 HAD FINALLY APPROVED A 2'S RETURN TO CUBA AND THAT A 2 SHOULD
 LEAVE ON NEXT FLIGHT. ALTHOUGH A 2 WAS DUBIOUS TOLD CALZADILLA
 HE WOULD GO, BUT NEEDED \$500 TO PAY OFF SOME LOCAL DEBTS AND
 WANTED SPEAK TO WIFE. SAME DAY A 2 FOUND OUT ABOUT AMLASH 1
 ARREST BUT NO MENTION OF SAME MADE BY EMB OFFICIALS.

B. ON 6 MAR CALZADILLA TOLD A 2 THAT AMB CARRILLO COMING
 FROM PARIS AND WOULD ACCOMPANY A 2 ON IBERIA FLIGHT TO
 HABANA 7 MARCH. ADDED THAT CARRILLO NOW VICE MIN FOREIGN AFFAIRS.
 CALZADILLA, ARISTIDES DIAZ, GUSTAVO MAZORRA AND TONY LOPEZ WENT
 WITH A 2 TO AIRPORT TO MEET CARRILLO. GROUP THEN WENT CUBAN EMB,
 WHERE CARRILLO EXPLAINED GOC HAD GOOD JOB OFFER FOR A 2 AND STAB
 A 2 WOULD HAVE "REAL FUTURE" IN CUBA. A 2 CERTAIN THEY LAYING

TAP FOR HIM BUT GAVE APPEARANCE "GOING ALONG" WITH THEM. CALZADILLA GAVE A 2 \$500 HE HAD REQUESTED. GROUP ESCORTED A 2 TO HIS HOTEL TO PICK UP PERSONAL LUGGAGE. A 2 ASKED THEM COME BACK FOR HIM IN FEW HOURS, BUT WHEN THEY RETURNED HE HAD DISAPPEARED. A 2 WENT TO SPANISH POLICE AND ASKED FOR PROTECTION, WHICH HE SAYS GRANTED.

2. A 2 MADE FOLL COMMENTS RE AMLASH 1 ARREST:

A. ENTIRE DIRECTORIO (NOT-COMMIE FACTION) NOW UNDER SUSPICION, INCLUDING AMPOSSUM 1 WHOSE DEPARTURE DELAYED.

B. ARRESTEES HAVE NOT TALKED YET AND MANY DETAILS OF PLOT NOT KNOWN BY GOC.

C. AT LEAST TWO OTHER MAJORS AND SEVERAL CAPTAINS INVOLVED WHO STILL FREE.

D. A 2 IN PHONE CONTACT WITH AMBIDDY 1 AND AMWHIP 1 WHO ATTEMPTING GET SUPPORT HIGH ODYOKE OFFICIALS TO TRY SAVE AMLASH 1. AMBIDDY 1 SENDING REP SPAIN TO TALK WITH A 2.
