DESENSITIZED TYPIC YNFOTE AMWORLD ANLASH

1. ANLASH/1 AND ANWHIP/1 RETURNED PARI 31 JANUARY. MET 1
FEBRUARY. ANLASH/1 PLANS RETURN PERUEN 18 FEBRUARY FROM MADRID.
TRAVELLING ON DIPLOMATIC PASSPORT D/04/663. REPORTED ROME POLICE
RECORDED NUMBERS ALL VISAS IN PASSPORT WHICH PRIMARILY FOR BLOC
COUNTRIES. WHEN EMPLANING ROME 31 JANUARY, ONE GUEVARA AND DELEGATION
APPROXIMATELY 15 CUBANS AT AIRPORT BUT ANWHIP/1 AND ANLASH/1 WERE
AVOID GROUP AND CERTAIN NOT SEEN BY CUBANS.

2. ^{AS}ANLASH/1 STATES FULL AGREEMENT REACHED WITH ANBIDDY/1
AND HE WELL SATISFIED WITH ARRANGEMENTS WHICH HE OUTLINED FOR OUR
INFORMATION (ALONG SAME LINES AS REPORTED BY ANBIDDY/1). ANLASH/1
REALIZES HIS PERSONAL SECURITY REDUCED BECAUSE OF ADDITIONAL PERMITS
NOW KNOWLEDGEABLE BUT FEELS THIS RISK MUST BE TAKEN IF PLAN IS TO BE
REALIZED. ANLASH/1 CLAIMS HE IS CONVINCED AND SO IS ANBIDDY/1
THAT IF ANYTHING TO BE DONE IT MUST BE THIS YEAR. HE REALIZES HIS
TIME IS LIMITED.

3. ANBIDDY/1 PROVIDING PACKAGE IN MADRID WHICH ANLASH/1 PLANS
CARRY BACK IN PERSONAL LUGGAGE. ANLASH/1 PRESENTLY TRYING HAVE

AMWORLD/1 DELIVER PACKAGE PARIS INSTEAD OF MADRID AS FEELS SECURITY IS BETTER IN PARIS AND FEWER PEOPLE WILL BECOME KNOWLEDGEABLE. HE ASKED IF THIS REQUEST COULD BE SENT BY KUBARK TO AMBIDDY/1 BUT WAS TOLD NO COMMUNICATIONS EXISTED. IT OBVIOUS AMLASH/1 FINDS THIS HARD TO BELIEVE BUT DECIDED TRY GET MESSAGE TO ANTONIO SANZ THRU AMWHIP/1. SINCE AMLASH/1 DID NOT PRESS REQUEST IT APPEARS AMBIDDY/1 DID NOT EXPOSE CONTACT. AMLASH/1 VOLUNTEERED HE TOLD AMBIDDY/1

OF HIS CONTACT WITH AMERICANS, SPECIFICALLY WITH NICK, AND ALSO THAT HE WAS KEEPING THE AMERICANS GENERALLY INFORMED OF THEIR PLANS.

4. AMBIDDY/1 OFFERED AMLASH/1 FINANCIAL HELP TO DEVELOP INTERNAL PLAN TO OPERATIONS. AMLASH/1 CLAIMS HE DID NOT ACCEPT OFFER AND INFORMED AMBIDDY/1 MONEY NOT NEEDED. STATES HE PREFERS NOT START RELATIONSHIP WITH AMBIDDY/1 ON FINANCIAL BASIS. FACT IS HE DOES NEED MONEY TO IMPLEMENT PRESENT PLAN BUT PREFERRED REQUEST HELP FIRST FROM KUBARK AS FEELS HAS BUILT UP MORE CONFIDENCE BECAUSE OF LONGER RELATIONSHIP. AMLASH/1 ESTIMATES HE NEEDS AT LEAST \$10,000.00 TO ORGANIZE THE INTERNAL GROUP AND PREFERS CARRY MONEY IN WITH HIM TO INSURE HE HAS IT WHEN HE NEEDS IT. AMLASH/1 ASKED AMWHIP/1 TO FIND PESOS FOR HIM BUT PESOS DIFFICULT FIND AND AMWHIP/1 [3. 1. 7/ 15; C.]

AMLASH/1 CLAIMS HE CAN SECURELY EXCHANGE DOLLARS FOR PESOS IN

PBRUMEN. ANLASH/1 WELL AWARE OF RISK HE IS RUNNING IF HIS LUGGAGE IS CHECKED ENTERING PBRUMEN. HE FEELS HIS LUGGAGE WILL NOT BE CHECKED SINCE HE TRAVELLING ON DIPLOMATIC PASSPORT AND HAS HAD NO REPORTS FROM PBRUMEN THAT HE UNDER SUSPICION. BECAUSE OF FOLLOWING REASONS RECOMMEND REQUEST BE FAVORABLY CONSIDERED AND CHARGED AM^{CI}WORLD EXTRAORDINARY EXPENSES:

- A. WE HAVE NO REPORTS OR INDICATION THIS PROVOCATION.
- B. DURING LONG RELATIONSHIP ANLASH/1 HAS BEEN GIVEN PERSONAL EXPENSE MONEY DURING TWO TRIPS OUTSIDE PBRUMEN BUT HAS NEVER ATTEMPTED MILK KUBARK FOR MONEY.
- C. SINCE HE WILLING RISK GOOD SECURITY IN ESTABLISHING RELATIONSHIP WITH AMBIDY/1 HE HAS DEMONSTRATED DETERMINATION TO GET ON WITH THE JOB.
- D. AND FINALLY AND MOST IMPORTANT, HE IS ONLY ASSET IN POSITION AND WILLING TO TRY AND ORGANIZE AN INTERNAL COUP. HE CLAIMS INTERNAL ASSETS AND CONTACTS WHICH WE HAVE BEEN ABLE TO CHECK AND HE GIVES EVERY INDICATION AT THIS TIME OF BEING DETERMINED TO PROCEED IN HIS ATTEMPT. THIS ATTITUDE CONFIRMED BY AMWHIP/1 WHO BETTER JUDGE OF ANLASH/1 FEELINGS BECAUSE OF LONG ACQUAINTANCE.
5. REVIEWED SV COMMUNICATIONS SYSTEM WITH ANLASH/1 AND MAILING ADDRESSES. HE PLANS HAND CARRY NEW SUPPLY OF CARBON AND DEVELOPER

FILLS WHICH HE HAS BEEN GIVEN. AMLASH/I CONCERNED AND QUESTIONED SECURITY OF SYSTEM SINCE HE HAD HEARD DSE WAS DEVELOPING SW LETTERS. AMLASH/I WAS TOLD WE HAD NO INDICATION THIS THE CASE. AMLASH/I WAS DEBRIEFED ON LIST OF REQUIREMENTS WHICH WILL BE REPORTED UPON RETURN HEADQUARTERS. AMLASH/I WAS GIVEN ADDITIONAL REQUIREMENTS AND SPECIFICALLY ASKED TO CHECK AND REPORT BY SW REGARDING PRESENT PRUMEN POLITICAL SITUATION AND DEVELOPMENTS SINCE HE HAS BEEN OUT OF COUNTRY.
