1. HYSAGE-1, CITING PINIERO AS SOURCE, REPORTS ORDOQUI MOVED FROM PRISON TO SMALL FARM OUTSIDE HAVA. HE STILL CONSIDERED TRAITOR BUT WHILE IN PRISON BECAME SICK AND WAS FOUND HAVE INCURABLE CANCER FROM WHICH EXPECTED DIE SHORTLY. ORDOQUI DAUGHTER, NAME UNX TO H-1, HAS APPLIED FOR PERMISSION LEAVE CUBA TO GO UNITED STATES AS EXILE.

2. H-1 SAYS PINIERO ALSO TOLD HER TWO DAYS PRIOR END CUBELLAS TRIAL WHAT SENTENCE WOULD BE AND WAS. H-1 SAID THAT DURING TRIP CUBA 1965 CUBELLAS ASKED IF SHE HAD EVER BEEN TO CANARY ISLANDS. CUBELLAS SAID HIS INTEREST STEMMED FROM PROJECT ON WHICH HE WORKING TO ASSASSINATE BATISTA.

3. H-1 ATTENDED ALMOST ALL SESSIONS CUBELLAS TRIAL AND FROM VIEWPOINT PRATICING ATTORNEY, TESTIMONY OF WITNESSES "FULL OF HOLES" AND IT OSVIOUS MANY MATTERS NOT CONTENDED PROBABLY DUE PRIOR ARRANGEMENT DEFENSE AND PROSECUTION.
