AMLASK/1 - Paris Station Aspect

Paris Station involvement with the AMLASH case began in 1962, after AMLASH/I came to Paris after attending the Helsinki Touth Postival that year. In Helsinki, AMLASH/I was contacted by UNRUMELE/2 (an asset of the Paris Station who attended the Postival for purposes of disruption) and by other KUBARK assets. It is not clear from our files just when AMLASH/I was "rescribed" but it appears that he was recruited during or shortly after the Festival.

In Paris he was in contect with Peter J. KDMINGHAM (probably in alias although I know that AMLASH/I was at KIMINGHAM's home upon occasion). In 1962 AMLASH/I was given training in explosives by ONIMIX (I believe) upon request of the Paris Station. He appears to have returned to PERINGE in late 1962. It is not known if other Paris Station personnel were in contect with AMLASH/I during that period.

AMEASE/I ment syrived in Paris on th September 1969, coming from the Intermettional Cames held in Prorto Alegro, Bresil, where he was in contact with TYPIC officers.

At this point AMERCAT/2 (now QUEFORT) was in contact with AMEASE/1 in Paris and AMMEP/1 was another common channel (the case being used primarily by Eqs.). The Essaquarters

TYPIC officer, OMTRICE (F), arrived in Paris on 3 October 1963 and picked up the contact with AMEASE/1 which was being religiously by AMERCAT/1 and EXPIRITARY. The meetings with AMEASE/1 took place in EXPIRITARY home as best I remember. These discussions concerned AMEASE/1 splane to assissinate AMPEDS and overthrow his regime.

CETRICE returned to Paris In late October, after discussions at Hadquarters on the case. Office and Dalmid, who was thy in Paris at the time, met with AMLASK/l in late October or early Howester. DAIMOID's participation was due to AMLASK/l strong desire to talk with case high-level ODYOKE official concerning his plane and to obtain ODYOKE blossing if possible. I same testage of exactly what happened at these mostings but I received the impression from KYMENHAM that such blossing was given.

WLASE/I returned to PERMEN on 27 Howester 1960. It was during this visit to Paris

Ton will recall that in December 196h USEMITUS had a narrows breakdown and AMIASE/I played an important part in convincing USEMITUS that he should agree to beepitelization. It was in this commention that CLOADEN and HODAMER met AMIASE/I.

CLOADEN subsequently met with AMIASE/I two or three times to received reports for STOCEMOOD. These meetings were becart meetings or in the home of UMERITUS.

During this stay, AMEASE/I traveled to Hadrid at least once to meet with AMENDUT/I and AMEANU/I. I am not sware of results of three meetings except that AMIASE/I was seeking the physical instruments to carry out his plan to climinate AMINED.

There was me additional contect with ANLASH/I in Paris subsequent to February

1965 but the (GLOAISH and MIRLES) did have subsequent contact with GESMAPU/5,

UMSHAPU/9, ANLASH/8 and ANLASH/3. You will recall the vit was ANLASH/3 who undo

the "joking" pitch to MIRLESS on 6 May 1965. ANLASH/2 and MMLSH/3 were both source

of ANLASH/I plane.
