On March 4, 1964 a confidential source abroad, advised that there is no information contained in security or police records in England. Alien records disclose GEORGE DE MORNAY-SCHILD arrived at London Airport from New York May 15, 1959 and remained in transit before departing that same date for Accra, Ghana. (C)

On arrival he advised immigration officials he was born April 17, 1911 at Ruxton and held U. S. Passport 289030 issued in Washington, D. C. on January 23, 1937. (C)


