1. (MADR) 3716 REPORT OF 5 APRIL MEETING WITH AMWHIP 1 AND AMLASH 2  
 QUOTES LATTER AS SAYING (MADR) 3716 DID NOT WANT ANY MORE PHONE CALLS AND  
 INTENDED TO TELL THIS TO OLIEH.

2. AT 5 APRIL MEETING WITH GROWERY, AMWHIP 1 DISCUSSED HIS MEETING  
 OF 4 APRIL WITH (MADR) 3716, (MADR) 3716 AND AMLASH 2 AND 3, QUOTING (MADR) 3716  
 AS STATING:

A. (MADR) 3716 DEFECTION ADDED TO PRESTIGE OF (MADR) 3716 AT MADR EMBASSY  
 AND AT PBRUMEN FOREIGN OFFICE (THIS DOES NOT JIBE WITH (MADR) 3716 INFO  
 FORWARDED REF B).

B. MINISTER IN MADR HAS RECOMMENDED TO FOREIGN OFFICE THAT  
 (MADR) 3716 BE REASSIGNED MADR AS FIRST SECRETARY.

C. REPEATED PHONE CALLS FROM OLIEH INDICATE ODYOKE DESIRE TO  
 MAKE (MADR) 3716 AN "AGENT". (MADR) 3716 IS A GOVT OFFICIAL AND DOES NOT WISH  
 TO BE AGENT. ODYOKE WANTS TO TRAIN (MADR) 3716 BUT HE DOES NOT WANT TO  
 BECOME INVOLVED.

3. AMWHIP 1 EXPRESSED BELIEF KUBARK SHOULD NOT CONTACT <sup>02</sup>QUHOPS.

4. NO NEW PERTINENT <sup>02</sup>QUOZE MATERIAL PRESENTLY AVAILABLE.

5. WITH REGARD TO 2A ABOVE, <sup>15-2</sup>STATION HAS NO HARD INFO AS TO BASIS FOR <sup>02</sup>QUHOPS REASONING. HOWEVER ON 23 MARCH <sup>02</sup>QUHOPS TOLD OLLEN THAT HE HAD FOUND AT EMBASSY COPY OF <sup>02</sup>QUALT LETTER TO ROGELIO PATINO IGLESIAS IN WHICH <sup>02</sup>QUALT EXPRESSED SUSPICION THAT <sup>02</sup>QUHOPS WAS RECEIVING FUNDS FROM ODYCKE. <sup>02</sup>QUHOPS SAID HE HAD KEPT COPY.
