OBJECT OF MISPAWN OP CITED DIR 92042 IS PLANT OF RUMOR WITH (UN)SNAFU/19 THAT ODYOKE ACCEPTS ORIGINAL GOALS OF PBRUMEN REVOLUTION AS SOUND, ACCEPTS FACT THERE SOME CAPABLE PBRUMENS STILL IN HIGH GOVT POSITIONS TODAY, AND THAT, AFTER OUSTER AMTHUG AND COMMUNISM, ODYOKE WILLING DEAL WITH THESE OFFICIALS.
