1. IF SUBJ REFUSES RECRUITMENT FOR USE INDICATED REF, REQUEST WAVE TEAM QUERY HIM ABOUT TRAVELING MOROCCO ATTEMPT RECRUIT IN PLACE CUBAN AMBASSADOR. IN MAY 1963 DEBRIEFING SUBJ STATED ENRIQUE RODRIGUEZ-LOECHES FERNANDEZ A CLOSE FRIEND WHEN BOTH IN DR. SUBJ ALLEGED RODRIGUEZ LOECHES DISLIKED AMTHUG-1 SINCE THEIR FIRST MEETING AND HAS SINCE STRONGLY EXPRESSED SAME FEELING. ALSO STATED CONVINCED HE COULD TALK DEFECTION OR RECRUITMENT WITH RODRIGUEZ LOECHES ON FRIENDLY TERMS SHOULD THEY HAVE OPPORTUNITY MEET.
2. ATTEMPT REINSTATE SUBJECT'S PREVIOUS POA UNDERWAY. WILL ADVISE ON RECEIPT.
