His stay was extended to 15 December 1960 because he stated his wife and child were in Cuba, he had lost his jewelry business to the CASTRO regime and he feared retaliation.

On 1 March 1961 he departed for Mexico from New York City and returned 15 March 1961. His residence was shown as 98-19 64th Ave., Forest Hills, N. Y., where he lived with his wife, CARIDAD LABRADOR. He stated that he was self-employed in the jewelry business, address not given.
