1. ODEMY REPORTS SALVADOR DIAZ VERNON, FORMER PUBLISHER CUBAN MAGAZINE (OCIDENTE AND LEADER CUBAN ANTI-COMMUNIST LEAGUE, IS LEADER ANTI CASTRO MOVEMENT SPONSORED BY ONE JOSE LUIS FUJOL. DIAZ TO SEE EMILIO NUNEZ PORTUONDO, FORMER CUBAN EMBASSY TO UNITED NATIONS, ON 27 MAY, PROBABLY TO DISCUSS UNITY ANTI-CASTRO MOVEMENT AS NUNEZ HAS OWN ANTI-CASTRO GROUP. NUNEZ PROMISED CUBAN PRESIDENCY BY LEADER OF ANOTHER, UNIDENTIFIED ANTI-CASTRO GROUP. DIAZ SET TO START LEAVING MIAMI 28 MAY FOR ASSEMBLY IN MEXI AND GUAT TO DISCUSS INVASION CUBA.
2. FOR GUAT, MEXI, REF FORWARDED ODEMY INFO THAT NUNEZ TO LEAVE MIAMI FOR TRUJ 17 OR 18 MAY TO SEE TRUJILLO RE UNIFICATION ANTI-CASTRO MOVEMENTS. TRUJILLO WANTED NUNEZ TO RETURN 20 MAY TO DISCUSS WITH ODEMY.
