According to the information the plot was to have been carried out on 15 September 1975; however, one of the major conspirators, Jorge Antonio "Cokie" ZIMERI Safie left Guatemala in August 1975 as a result of an attack upon his, ZIMERI's, life. ZIMERI has been living in Miami since August 1975.

According to the report, the National Liberation Movement was involved with ZIMERI in the assassination plot and ZIMERI in turn was involved with two Americans, brothers, Robert and Gerald Patrick HENMING.
