C/S COMMENT: *LITEMPO WAS REQUESTED ON 3 DECEMBER TO SEND TELEGRAM MEXI CONSUL HABANA AUTHORIZING NIEXIT-3 TRANSIT MEXI EITHER WITH VISA OR TOUR ST CARD.

1. FACT REF A STATES LITEMPO WAS REQUESTED ON 3 DECEMBER TO SEND TELEGRAM WHILE REF B STATES NIEXIT-3 DID NOT CABLE UNTIL 4 DECEMBER, HQS ASSUMES THAT STATION REQUESTED LITEMPO ASSIST IN OBTAINING MEXI TRANSIT VISA FOR AMBOUR-1 ON BASIS OTHER THAN REF B.

2. IN ANY EVENT, LITEMPO ~~UNDOUBTEDLY PARTIALLY SICKLY~~ SINCE AMBOUR-1 WAS TERMINATED AS KUBARK AGENT IN JUNE 1963 AND PRESENTLY INVOLVED IN A STRICTLY PERSONAL VISIT TO BELGIUM TO SPEND HOLIDAYS WITH HIS FAMILY. AMBOUR-1 UNDOUBTEDLY PLANS RETURN TO PRUGHEN AFTER CONCLUSION OF VISIT. LITEMPO'S INTERMISSION OPENS DOOR TO POSSIBLE IDENTIFICATION SUBJECT WITH ESPIONAGE.

3. REQUEST MEXI VIEW DEGREE OF RISK AMBOUR WILL ENCOUNTER AS RESULT LITEMPO ACTION IF HE RETURNS TO PRUGHEN.
