SUBJECT: Alleged Batistianos Signed up for the camps. MRP

1. Manolo RAY telephoned me Saturday night to tell me that he had heard from his Miami contact that a number of Batistianos had been recruited for training in the "camps" and some had already been flown to the camp. He said he understood this resulted from inadequate checking and that the presence of these people at the camps could cause considerable trouble. He mentioned only one name - Cruz Vidal - but said he would seek additional info. Following Manolo's call I phoned [] and passed the info on to him. He was already well aware of the problem and was taking remedial action.

2. On Sunday night, 26 February, Manolo called me again. This time he read to me over the phone the names of (1) a number of alleged undesirables who had been recruited and dispatched (2) a number who have signed up by who as yet have not been accepted and (3) names of people who are involved in the recruiting without necessarily implicating them in any questionable activity:

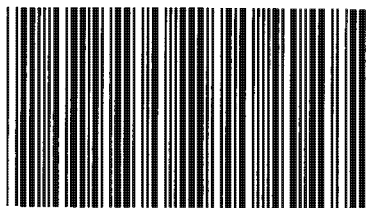

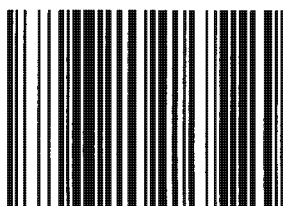

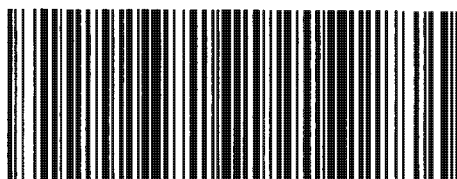

SUBJECT : Ricardo MORALEZ [MORALEZ] / ACT 500A

1. Reference is made to your memorandum, dated 23 December 1960, entitled "Cuban Intelligence Activities in the United States," in which subject provided information on the Cuban G-2 organization. in U.S.

2. Regarding referenced memorandum, the following data, dated January 1961, was provided by a fairly reliable source who has extensive contacts in Cuban emigre circles in the Miami, Florida area:

The Movimiento Revolucionario del Pueblo (MRP) has established a military training camp on a farm located at Bauer Drive, Homestead, Florida, and about four blocks from a farm owned by Noto V'S. OFZ. The following members of the MRP reportedly were receiving training:
