- 4. THE ARRB HAS REQUESTED STATE AND AGENCY HELP IN GETTING ACCESS TO THE KGB RECORDS ON OSWALD. THE RECORDS, ORIGINALLY HELD SECRET

\*IN MINSK, WERE FLOWN TO MOSCOW IN '63 FOLLOWING THE<ASSASSINATION,> THEN RETURNED TO MINSK WHERE THEY ARE STORED TODAY. WHEN APPROACHED BY STATE AND THE ARRB, THE BELARUSIANS HAVE SHOWN SAMPLES FROM THE FILE BUT HAVE NOT AGREED TO ARRANGEMENTS TO COPY. THE ARRB CHARTER EXPIRES ON 30 SEPT 98 AND THE OLD KGB FILE(S) IS A MAJOR OUTSTANDING REQUIREMENT. STATE HAS MANAGED TO GET THE SUBJECT AS THE NUMBER ONE TALKING POINT ON VICE PRES GORE'S RECENT CONFERENCE DISCUSSIONS. THE BELARUSIAN RESPONSE WAS TO TRY IT AGAIN LOCALLY IN MINSK, OFFERING INCREASED "COPY FEES".

5. THE ARRB CHAIRMAN HAS COME BACK TO STATE TO ASK THEY CONTACT THE AGENCY WITH THE FOLLOWING REQUEST: CAN THE STATION CHECK-WITH THE FSB/SVR TO DETERMINE WHETHER THE RUSSIANS RETAINED *A COPY OF THE LEE HARVEY OSWALD'S KGB FILE IN MOSCOW? CAN WE GET ACCESS TO THE FILE AND, PRESUMABLY, OBTAIN A COPY FOR THE ARRB? WE NOTE THAT THE ARRB WILL PROBABLY PUSH HARD TO DECLASSIFY THE RUSSIAN DOCUMENTS AS WELL. OBVIOUSLY SUCH A REQUEST COULD HAVE SEVERAL IMPLICATIONS WHICH WE MUST CAREFULLY CONSIDER, I.E., THE RUSSIANS MIGHT ASK FOR FILES OF THE ROSENBERGS OR OTHER NOTORIOUS PERSONALITIES. THE HQS CONTEXT IS THAT WE ARE GRAPPLING WITH THE ARRB ON A VARIETY OF OTHER SERIOUS DECLASSIFICATION/DISCLOSURE ASSUES AND WE MIGHT BE ABLE IN A BETTER NEGOTIATING POSITION IF WE COULD BE SEEN AS ASSISTING THEIR EFFORTS TO GET THE OSWALD FILE.  6. OBVIOUSLY SUCH AN ACTION HAS TREMENDOUS IMPLICATIONS AND WE WELCOME A FULL DIALOGUE FROM STATION ON THIS MATTER.
