F. IS THERE POSSIBILITY OF HOSTILE USE (E.G. RUSSIAN OR CUBAN) TO DISCREDIT US EMBASSY AS A "NEST OF SPIES" OR SIMILAR?

THIS IS A POSSIBILITY, BUT WE WOULD EXPECT THAT ANY HOSTILE EXPLOITATION WOULD BE SEEN IN PRESS PLACEMENT/PROPAGANDA RE A "NEST OF SPIES" VICE A DIPLOMATIC PROTEST. WE WOULD NOT EXPECT THAT SUCH PRESS COVERAGE, IF UNSUBSTANTIATED, WOULD HAVE A NEGATIVE IMPACT ON OUR [REDACTED] GOVERNMENT-TO-GOVERNMENT RELATIONS. IF SUCH PRESS EXPLOITATION BY HOSTILE SERVICES DREW ON SPECIFIC AND CONCRETE EXAMPLES OF [REDACTED] IT COULD NEGATIVELY IMPACT OUR ABILITY TO SUSTAIN SOME UNILATERAL ACTIVITY DUE TO A POSSIBLE INCREASE OF [REDACTED] SCRUTINY OF OUR OFFICERS (SEE BELOW).
