PLEASE BE AWARE THAT YOUR NAME APPEARS IN DOCUMENTS THAT ARE BEING REVIEWED FOR RELEASE TO THE PUBLIC UNDER PUBLIC LAW 102-526 \*OF 26 OCTOBER 1992, THE PRESIDENT<JOHN>F.<KENNEDY ASSASSINATION> RECORDS COLLECTION ACT OF 1992. THIS MANDATES THE PUBLIC RELEASE OF ALL INFORMATION IN THESE DOCUMENTS, INCLUDING YOUR NAME WHERE IT APPEARS, UNLESS THE ORIGINATING AGENCY CAN PROVE BY CLEAR AND CONVINCING EVIDENCE TO A PRESIDENTIALLY-APPOINTED BOARD THAT ONE OR MORE LIMITED EXCEPTIONS APPLY. EVEN THEN, THE RELEASE OF THE INFORMATION MAY ONLY BE POSTPONED FOR NO MORE THAN 25 YEARS. THE ACT IS VERY PRO-RELEASE AND REQUIRES A BALANCING OF THE PUBLIC INTEREST.

UNDER THE BOARD'S INTERPRETATION OF THE ACT, YOUR NAME CANNOT BE REDACTED FROM THE DOCUMENTS TO BE RELEASED UNLESS WE CAN PROVIDE EVIDENCE THAT THIS RELEASE WOULD POSE A CREDIBLE THREAT TO SECRET
