1. 29 NOV ADOLF JAY ALBRECHT (PRONOUNCES NAME ALBRIGHT), DPOB 15 JUNE 26 NEW JERSEY, US PASSPORT D294080 ISSUED NY 18 APR 63, OCC INDUSTRIAL ADVERTISING COPYWRITER, REQUESTED INTERVIEW "SECURITY OFFICER." JACONNETY INTERVIEWED IN PBSWING IN TRUE NAME SAME EVENING. SUBJ SAYS HE FORMER BOYFRIEND CHARLOTTE ABERG, SWEDISH CIT DOB CA 1943. CHARLOTTE MOTHER (NAME UNKNOWN) MARRIED ARNE ABERG (DENTIST ACCORDING STOC TEL BOOK) BUT HAS MANY BOY-FRIENDS, ONE OF WHOM IS KARL-ERIK RIDDERSTRALE (R) PROBABLY IDENTICAL WITH NOBILITY HANDBOOK KARL-ERIK RIDDERSTRALE DOB 24 SEP 22, LISTED AS SALES CHIEF. SUBJ HIMSELF WORKS ANDERSSON AND LEMBKE ADVERTISING AGENCY, LUNTMAKARGATAN 95, STOC, NOT LISTED PHONE BOOK "BECAUSE IT TOO NEW".

2. SUBJ SAYS CHARLOTTE AND MOTHER VISITED BY R 15 NOV. R. NORMALLY QUIET, REFINED, BUT GOT DRUNK, PREDICTED KENNEDY ASSASSINATION WITHIN 2 WEEKS WHILE ON JOURNEY AMONG OWN PEOPLE. R LEFT WING AND STRONG FIDELIST, THO NOBLEMAN AND RICH. AFTER ASSASSINATION CHARLOTTE UPSET AND CALLED SUBJ EVENING 27 NOV TO REPORT ABOVE QUOTE. SUBJ

CALLED PBSWING<sup>2</sup> LATE AFTERNOON 29 NOV.

3. SUBJ MEETING CHARLOTTE 30 NOV. HE TOLD TO ADVISE HER COME PBSWING<sup>2</sup> FOR INTERVIEW PERSONALLY DURING COMING WEEK. INTERVIEW TO BE ARRANGED BY CALL FROM PBSWING<sup>2</sup> TO HER, BUT WE WILL CALL SUBJ FIRST TO MAKE SURE SHE CONCURS THIS ARRANGEMENT.

4. CHECK WITH COMMERCIAL SECTION 30 NOV REVEALS SUBJ KNOWN AS SOMETHING OF WASTREL WHO HAS HAD GOOD JOB OPPORTUNITIES BUT NEVER PRODUCES, LIVES OFF UNKNOWN RESOURCES. SUBJ ALSO PRODUCED BAD IMPRESSION ON JACONNETY WHO FELT HE WITHHOLDING INFO OR PREVARICATING.

5. MOST LIKELY EXPLANATION IS SUBJ DESIRE MAKE MONEY OFF KUBARK<sup>3</sup> AND RECENT TRAGEDY, BUT CERTAIN ASPECTS SUBJ LIFE HERE AND MANNER APPROACH SUGGEST POSSIBLE RIS INVOLVEMENT REQUEST PRIORITY KUBARK, ODENVY, AND ODOATH<sup>5</sup> CHECKS SUBJ. HE SERVED ODOATH APPROX 1947-55, BUT ONLY TWO WEEKS ACTIVE DUTY. ALSO REQUEST KUBARK CHECKS R AND ABERGS PLUS COMMENTS SIMILAR CASES ELSEWHERE. STA TRACES REVEAL ONE ARNE KARL ABERG ON SCP LIST FOR LINKOPING IN 49, ONE GEORG FOLKE VALLENTIN LEMBKE DOB 14 FEB 09 AS POTENTIAL FIFTH COLUMN LINKOPING. LATTER NAME RELATIVELY RARE HERE. NO OTHER STA TRACES.

6. IF SUBJ SAYS CHARLOTTE UNWILLING COME PBSWING<sup>2</sup>, WE TENTATIVELY PLAN RATHER HARD APPROACH TO SUBJ PERSONALLY TO TRY DETERMINE HIS MOTIVATION AND WHETHER ANYTHING BUT MONEY-MAKING BEHIND IT. PLS ADVISE.
