1. 31 DEC TIPSTAFF/4 REPORTS, THEY INVESTIGATING ~~RIDDERSTRALE~~  
VIA ONE OF HIS CONTACTS. CONFIRMS HE IN CUBA IN 56 AND FACT HE  
DRUNKARD. NO DECISION YET RE DIRECT INTERVIEW SINCE THEY FEAR HE  
WILL SIMPLY DENY ALLEGED STATEMENT TO CHARLOTTE. T/4 SAYS HE  
REALIZES OUR CONCERN AND HOPES HAVE DECISION "SOON". IMPLIED T/10  
WOULD MAKE DECISION.

2. OUR BELIEF DECISION DELIBERATELY PUT OFF UNTIL T/1 STEPS  
DOWN, AS OF 1 JAN. T/4 NOTED T/1 WOULD HAVE SOME SAY IN TIPSTAFF  
MATTERS AND WOULD SPEND ONE HOUR PER DAY THERE UNTIL 1 JULY, BUT  
THAT T/10 IN EFFECT WOULD BE ACTING CHIEF.
