Letter Accusing the Chinese Communists of Plotting the Assassination of Provident Reasony Received by U.S. Embassy Stockholm

- 1. Reference is made to paragraph two of your memorandum, deted to rebruary, requesting copies of disceminations relative to the assassination of President Kennsey that were sent to the Secret Service.
- a. Thortly after the assassination the United States arobassy in Stockholm received a latter, malled on 35 November 1968, which accused the Chinese Communists of plotting this act. This information was disseminated on 9 December to the white lieuse. Department of State, Federal Survey of Investigation, with a copy to the Secret Service. The exact text of the dissemination is attached to this memoranium.
- I. You will note that, as stated in the last sentence of the strachment, this letter was to be submitted to technical analysis by CIA experts who have concluded that the latter was probably written by a Swede, using a Swedish keyboard typewriter and Swedish stationary.
- 4. In view of the lact that this letter was received at the United States Embassy, the Commission may have siready received information about the nonument from the Department of State.

- 1. The American Embassy in Stockholm, Seeden, has received a letter mailed 25 November 196% in Stockholm alleging that the accusaination of Precident Manurdy was arranged by the Red Chinese. The letter purports to be from one Ryo Liang Yuan of the Red Chinese Embessy in Stockholm, but no such official is assigned there and there is no record of a Chinese efficial by this name anywhere abread.
- The letter is written in broken English and states that the Chinese Communists got in contact with Chinal when he are in the Soviet Union. Then CSTALD returned to the U.S.A., the Red Chinese re-contacted him, threatened to expose him if he did not cooperate. The Red Chinese expected that the U.S. would attack Caina when it learned that the assauda was a Cuban sympathizer. The Soviets would then attack the U.S.A., the Red Chinese would sak Soviets for atomic weapons, the Communist Bloc would win the war, the Chinese Reds would then assaudants Khruschev and take over control.
- The writer said he worked for the "Cepartment of State Secret", but no department by this name is known in the Chinese Communist Covernment. Our Judges this to be a crank letter. The original latter is being sent here for analysis.
