1. BACKGROUND. PRESS, WIRE SERVICES TODAY REPORT ARREST IN LEOPOLVILLE, CONGO, TWO SOV DIPLOMATS, BORIS VOZNEKH, COUNSELOR SOV EMB, YURI NYKOTSEKH, PRESS ATTACHE, UPON RETURN FROM BRAZZAVILLE (CAPITAL FORMER FRENCH CONGO), WHEN INSPECTING DOCUMENTS, PROVING SOV SUPPORT FOR CHRISTOPHE GBENYE, FOLLOWER OF LATE LUMUMBA, NOW TRYING FORM CONGO EXILE GOVT IN BRAZZAVILLE, FOUND IN THEIR POSSESSION. SOV GOVT NEWSPAPER IZVESTIA, MOSCOW, 20 NOV, DENOUNCED "SHAMEFUL PROVOCATION" AND "BANDIT METHODS". CONGO GOVT EXPECTED TO SUSPEND OR BREAK DIPL RELATIONS WITH SOVS, CZECHS.
