3. HQS NOTES WITH CONSIDERABLE INTEREST RECENT LETTER  
FROM GPBEPIT, BEING POUCHED, WHICH REFERS TO RECENT EXPLOSION  
IN SIEMPRE. GPBEPIT NOTES THAT EDITORS OF REVISTA MEXICANA DE  
LITERATURA APPEAR TO WANT TO TAKE ADVANTAGE OF THIS AND MAKE  
THEIR MAGAZINE INTO SUITABLE ALTERNATIVE TO SIEMPRE CULTURAL
