In discussing the paragraph 3 requirement in reference A for names of the Chiefs and Deputy Chiefs of the 6 Research Section in 1960-62 with one of the former Deputy Branch Chiefs of SR-6, we were made aware of the fact that SR-6 had a Section called the <u>Research Section</u> which later was called the <u>Operational Support Section</u>. We had been under the impression that the HSCA was interested in the identities of the Chiefs and Deputy Chiefs of SR-6, which was provided under reference C.

2. As nearly as we can determine at this time, the Research Section of SR-6 had no Chief or Deputy in 1960. Mr. Rudolph Balaban was made Section Chief from September 1961-62. Mr. Balaban resigned in 1970 and we have no address. He had been assigned to the Section from August 1960 to April 1964.
