Also enclosed for your information is one cony each of CIA memoranca sated 6/21/59 and 6/2/59; Duleta to Wid 5/13/60 and to Boston 5/25/60, Eoston letter to the Director dated 6/30/00; Docton report dated 8/31/00, all pertaining to subject. The above are being furnished for the completion of your file.

On 1/12/70 CIA advised through liaison that the subject & is not of coerational interest to that Agency. With regard to the subject is disamearance, CIA advised it did receive a renog grand which could be characterized as a ruror, that the subject was experiencing marital difficulties and had left his wife. Agency does not have any information concerning subject's present whereaboute.

In subsequent communications concerning this matter you should delete the character of IS - CZ and use the character & s of this letter.

Unless additional pertinent information is developed, no investigation need be conducted by your office. If additional pertinent information is received concerning this matter it should promptly be furnished to the Bureau by LHH.

was of some interest to CIA. On 4/15/39 CIA advised through lialson that subject had not left the U.S. and had been having difficulty with his wife and "ran away from her." CIA advised the story or rumor indicating subject may have gone to CZ was without foundation. In 12/69 Denver received a letter from subject's mother requesting information concerning subject's disappearance. Denver replied this was a matter not within the jurisdiction of the Eureau; however, offered if she so desired to place his name on the Bureau's missing persons list. Subject's mother replied to our Denver Office on 1/13/70 declining to have subject's name placed on the list. On 12/23/69 "The Denver Post," a daily newspaper in Denver, - Colorado, published a lengthy article concerning the disappearance of subject. By letter dated 1/8/70 Congressman Brotzman, R-Colorado, also requested information concerning subject's disappearance from the AG. We have conduced no investigation of subject's disappearance since there are no indications of a violation of Federal law in our jurisdiction,
