Podro Tuis Diaz Lens, former chief of the Cuban Air Force, on July 2, 1959, advised our Hiemi Office he had departed Cuba in secrecy on June 29, 1959, after he had been severely reprimended and ordered to perform no further duties as an Air Force officer by Fidel Castro. He revealed he was reprimended because of a news release to redic, television and nowspaper outlets in Cuba a newspaper outlets in Cuba in which he expressed opposition to my type of a dictatorship whether it be truillien Botista or commist.

Dias advised he is deeply concerned over the placing of communists in key positions in the Cuban Government and the armed forces by Fidel Castro and his brother, Raul Castro. He revealed that communist indoctrination classes have been held for combors of the Cuban Army and he claimed that he refused to ellow such classes to be scheduled for the Air Force. He indicated that many Cuben soldiers were refusing to ettend the classes.
